## "ANNULLING

THE BOOK OF VOTERS OF THE MUNICIPALITIES/CITIES IN THE AUTONOMOUS REGION OF MUSLIM MINDANAO, DIRECTING THE COMMISSION ON ELECTIONS TO IMMEDIATELY CONDUCT A NEW GENERAL REGISTRATION OF VOTERS IN THE REGION, PROVIDING FUNDS THEREFORE, AND FOR OTHER PURPOSES"

have considered the same and had the honor to report it back to the Senate with

the recommendation that it be approved with the following amendments.

1. On the first WHEREAS clause, page 1, line 2 - after the acronym

"BP", delete the number "81" and replace it with the number "881";

- 2. On the fourth WHEREAS clause, page 1, line16 after the word "population", delete the phrase "growth rate" and in lieu thereof insert the punctuation mark "comma" (,) and followed with the phrase "EXCLUDING ARMM" with a punctuation mark "comma";
- 3. On the tenth WHEREAS clause, on page 2, line 14 after the phrase "Executive Department", delete the phrase "has publicly" and in lieu thereof insert the punctuation mark "comma" (,) and followed with the phrase "THE COMMISSION ON ELECTIONS, THE ARMM REGIONAL GOVERNOR AND ALL STAKEHOLDERS, HAVE";
- On the RESOLVED FURTHER clause, page 2, line 23 after the phrase "non-ARMM areas", insert the phrase "TO BE DESIGNATED BY THE COMELEC"; and
- Also on the same clause, page 2 after the word "suspended", delete the phrase "<u>effective immediately until 31 August 2012</u>" and in lieu thereof insert the phrase "FOR THE WHOLE MONTH OF JULY 2012".
