





AN ACT CONVERTING THE BAYAWAN CITY LAND  
TRANSPORTATION OFFICE (LTO) EXTENSION OFFICE  
INTO A REGULAR LTO DISTRICT OFFICE

*Be it enacted by the Senate and House of Representatives of the Philippines in  
Congress assembled:*

1           SECTION 1. The existing Bayawan City Land Transportation Office  
2 (LTO) Extension Office is hereby converted into a regular LTO District  
3 Office. For this purpose, the Chief of the LTO, in consultation with the  
4 Secretary of the Department of Transportation and Communications, shall  
5 enact the rules and regulations for the implementation of this Act.

6           SEC. 2. The Secretary of Transportation and Communications shall  
7 immediately include in the Department's programs the operationalization of  
8 the LTO District Office in Bayawan City, the initial funding of which shall be  
9 charged against the current year's appropriations of the Bayawan City LTO  
10 Extension Office. Thereafter, such sums as may be necessary for the continued  
11 implementation of this Act shall be included in the annual General  
12 Appropriations Act.

1           SEC. 3. This Act shall take effect after fifteen (15) days following its  
2 publication in two (2) newspapers of general circulation.
