AN ACT CONVERTING THE EXTENSION OFFICE OF THE
LAND TRANSPORTATION OFFICE (LTO) IN QUIRINO,
MUNICIPALITY OF LUNA, APAYAO INTO A REGULAR
LTO DISTRICT OFFICE AND APPROPRIATING FUNDS
THEREFOR

*Be it enacted by the Senate and House of Representatives of the Philippines in
Congress assembled:*

1 SECTION 1. The Apayao Extension Office of the Land Transportation
2 Office (LTO) located in Quirino, Municipality of Luna, Apayao is hereby
3 converted into a regular LTO District Office.

4 SEC. 2. The Secretary of Transportation and Communications shall
5 immediately include in the Department's programs the operationalization of
6 the LTO District Office in Quirino, Municipality of Luna, Apayao, the initial
7 funding of which shall be charged against the current year's appropriations of
8 the Apayao LTO Extension Office. Thereafter, such sums as may be necessary
9 for the continued implementation of this Act shall be included in the annual
10 General Appropriations Act.

1 SEC. 3. The Department of Transportation and Communications shall
2 promulgate the necessary rules and regulations for the implementation of this
3 Act.

4 SEC. 4. This Act shall take effect fifteen (15) days following the
5 completion of its publication in the *Official Gazette* or in two (2) national
6 newspapers of general circulation.
