

have considered the same and have the honor to report it back to the Senate with the recommendation that the attached **H. B. No. 2266** be approved without amendment.







AN ACT CONVERTING THE EXTENSION OFFICE OF THE LAND
TRANSPORTATION OFFICE (LTO) IN THE CITY OF
DASMARIÑAS, CAVITE INTO A REGULAR DISTRICT OFFICE
TO BE KNOWN AS THE LTO DISTRICT OFFICE OF
DASMARIÑAS CITY, CAVITE, APPROPRIATING FUNDS
THEREFOR AND FOR OTHER PURPOSES

*Be it enacted by the Senate and House of Representatives of the Philippines in
Congress assembled:*

1 SECTION 1. The Extension Office of the Land Transportation Office
2 (LTO) in the City of Dasmariñas, Cavite is hereby converted into a regular
3 District Office to be known as the LTO District Office of Dasmariñas City,
4 Cavite.

5 SEC. 2. The Secretary of Transportation and Communications shall
6 immediately include in the Department's programs the operationalization of
7 the LTO District Office in Dasmariñas City, Cavite, the initial funding of
8 which shall be charged against the current year's appropriations of the
9 Dasmariñas City LTO Extension Office. Thereafter, such sums as may be
10 necessary for the continued implementation of this Act shall be included in the
11 annual General Appropriations Act.

1 SEC. 3. This Act shall take effect fifteen (15) days following the
2 completion of its publication in the *Official Gazette* or in two (2) national
3 newspapers of general circulation.
