



PURPOSE."**


have considered the same and have the honor to report it back to the Senate with the recommendation that the attached **H. B. No. 1967** be approved without amendments.

**AN ACT CONVERTING THE LAND TRANSPORTATION OFFICE (LTO)
EXTENSION OFFICE LOCATED IN TUBOD, LANA DEL
NORTE INTO A REGULAR LTO DISTRICT OFFICE,
APPROPRIATING FUNDS THEREFOR AND FOR OTHER
PURPOSES**

*Be it enacted by the Senate and House of Representatives of the Philippines in
Congress assembled:*

1 **SECTION 1.** The existing Land Transportation Office (LTO) Extension
2 Office located in Tubod, Lanao del Norte is hereby converted into a regular
3 LTO District Office.

4 **SEC. 2.** The Secretary of the Department of Transportation and
5 Communications shall issue such rules and regulations necessary for the
6 effective implementation of this Act.

7 **SEC. 3.** The Secretary of Transportation and Communications shall
8 immediately include in the Department's programs the operationalization of
9 the LTO District Office in Tubod, Lanao del Norte, the initial funding of which
10 shall be charged against the current year's appropriations of the Tubod LTO
11 Extension Office. Thereafter, such sums as may be necessary for the continued

1 implementation of this Act shall be included in the annual General
2 Appropriations Act.

3 SEC. 4. This Act shall take effect fifteen (15) days following the
4 completion of its publication in the *Official Gazette* or in two (2) national
5 newspapers of general circulation.
