The Committees on Justice and Human Rights *and* Finance, to which was referred S. No. 3035, introduced by Sen. Escudero, entitled:

"AN ACT

CREATING AN ADDITIONAL BRANCH OF THE MUNICIPAL TRIAL COURT IN CITIES AND SEVEN ADDITIONAL BRANCHES OF THE REGIONAL TRIAL COURT IN THE SEVENTH JUDICIAL REGION TO BE STATIONED AT THE CITY OF LAPU-LAPU, PROVINCE OF CEBU, FURTHER AMENDING FOR THE PURPOSE BATAS PAMBANSA BILANG 129, OTHERWISE KNOWN AS "THE JUDICIARY REORGANIZATION ACT OF 1980", AS AMENDED, AND APPROPRIATING FUNDS THEREFOR."
