

**MR. PRESIDENT:**

The Committees on Justice and Human Rights and Finance, to which was referred S. No. 3016, introduced by Sen. Escudero, entitled:

**“AN ACT  
CREATING FOUR ADDITIONAL BRANCHES OF THE METROPOLITAN  
TRIAL COURT IN THE NATIONAL CAPITAL JUDICIAL REGION TO BE  
STATIONED AT THE CITY OF LAS PIÑAS, FURTHER AMENDING FOR THE  
PURPOSE BATAS PAMBANSA BILANG 129, OTHERWISE KNOWN AS “THE  
JUDICIARY REORGANIZATION ACT OF 1980”, AS AMENDED, AND  
APPROPRIATING FUNDS THEREFOR.”**

APPROPRIATING FUNDS THEREFOR.”**


have considered the same and have the honor to report it back to the Senate with the recommendation that S.No. 3016 be approved with amendment, taking into consideration H. No. 5732.

The amendment is as follows:


