Separability Clause. - If, for any reason, any provision of this 23 Act is declared to be unconstitutional or invalid, the other sections or 24 25 provisions hereof which are not affected shall continue to be in full force and

SEC. 6. Repeating Clause All laws, decrees, executive orders, rules
and regulations and other issuances or parts thereof which are inconsistent with
this Act are hereby repealed accordingly.
SEC. 7. Effectivity Clause This Act shall take effect fifteen (15)
days after its publication in the Official Gazette or in at least two (2)
newspapers of general circulation, whichever comes earlier.
