Mr. President:

The Committee on Youth, Women, and Family Relations to which were referred Senate Bill No. 2080, introduced by Senator Cayetano (P.), entitled:

AN ACT DECLARING NOVEMBER TWENTY- FIVE OF EVERY YEAR AS "NATIONAL CONSCIOUSNESS DAY FOR THE ELIMINATION OF VIOLENCE AGAINST WOMEN"

taking into consideration Senate Bill. No. 1099, introduced by Senator Villar, entitled:

AN ACT DECLARING NOVEMBER TWENTY- FIVE OF EVERY YEAR AS "NATIONAL CONSCIOUSNESS DAY FOR THE ELIMINATION OF VIOLENCE AGAINST WOMEN"

and

House Bill No. 4434, introduced by Representatives Ilagan, De Jesus, Rodriguez (R.), Rodriguez (M.), Amante-Matba, Lacson-Noel, Tinio, Herrera-Dy, Mercado-Revilla, Castro, Bernos, Ferriol, Colmenares, Casiño, Mariano, Palatino, Obillo, Climaco and Primicias-Agabas, entitled:

AN ACT DECLARING NOVEMBER 25 OF EVERY YEAR AS "NATIONAL CONSCIOUSNESS DAY FOR THE ELIMINATION OF VIOLENCE AGAINST WOMEN"

has considered the same and has the honor to report it back to the Senate with the recommendation that it be approved with the following amendments:

- 1. On page 2, Section 2, subsection (d), replace the words "National Commission on the Role of Filipino Women (NCRFW)" with the words PHILIPPINE COMMISSION ON WOMEN (PCW);
- 2. On page 3, Section 3, after the phrase "the Department of Social Welfare and Development" and the comma (,), insert the phrase THE DEPARTMENT OF LABOR AND EMPLOYMENT and the comma (,);
- 3. On the same page and section, replace the acronym "NCRFW" with the acronym **PCW**;
- 4. On the same page, insert a new Section 4 to read:

SEC. 4 THE PCW AND THE INTER-AGENCY COUNCIL AGAINST TRAFFICKING (IACAT), CONSTITUTED UNDER SECTION 20 OF REPUBLIC ACT NO. 9208 OR THE "ANTI-TRAFFICKING IN PERSONS ACT OF 2003" AND THE INTER-AGENCY COUNCIL ON VIOLENCE AGAINST WOMEN AND THEIR CHILDREN (IAC-VAWC), CONSTITUTED UNDER SECTION 39 OF REPUBLIC ACT NO. 9262 OR THE "ANTI-VIOLENCE AGAINST WOMEN AND THEIR CHILDREN ACT OF 2004," SHALL COORDINATE, MONITOR AND EVALUATE THE ACTIVITIES OUTLINED IN THE ANNUAL EIGHTEEN (18)-DAY CAMPAIGN AT THE NATIONAL LEVEL.

AT THE REGIONAL LEVEL, THE REGIONAL INTER-AGENCY COMMITTEE ON ANTI-TRAFFICKING-VIOLENCE AGAINST WOMEN AND THEIR CHILDREN (RIACAT-VAWC) SHALL LIKEWISE COORDINATE, MONITOR AND EVALUATE SAID ACTIVITIES FOR THE ANNUAL CAMPAIGN AT THE PROVINCIAL, CITY, MUNICIPAL AND BARANGAY LEVELS. THEY SHALL ALSO MAKE AN ANNUAL REPORT OF THEIR FINDINGS TO BE REPORTED TO THE PUBLIC EVERY NOVEMBER 25.

THE PCW, THE IACAT AND THE IAC-VAWC SHALL LIKEWISE COORDINATE AND TAP THE EXPERTISE OF OTHER GOVERNMENT AGENCIES AND INSTITUTIONS LIKE THE MOVIE AND TELEVISION REVIEW AND CLASSIFICATION BOARD (MTRCB) AND THE OVERSEAS WORKERS WELFARE ADMINISTRATION (OWWA), AS WELL AS OTHER PRIVATE SECTOR ORGANIZATIONS IN THE IMPLEMENTATION OF ACTIVITIES FOR THE EIGHTEEN (18)-DAY CAMPAIGN.

- 5. On the same page, Section 4, after the figure "(5%)," delete the period (.);
- On the same page and section, after the word "units," add the phrase AS MANDATED BY SECTION 36 OF REPUBLIC ACT NO. 9710 OR "THE MAGNA CARTA OF WOMEN"; and
- 7. Renumber the sections accordingly.
