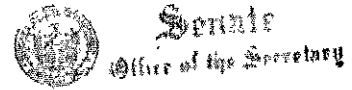

AN ACT
INSTITUTIONALIZING THE OPEN HIGH SCHOOL SYSTEM IN THE
PHILIPPINES, APPROPRIATING FUNDS THEREFOR AND FOR OTHER
PURPOSES

Be it enacted by the Senate and the House of Representatives of the Philippines in Congress assembled:

SECTION 1. Short Title - This Act shall be known as the “**Open High School System Act**”.

SECTION 2. Declaration of Policy - It is hereby declared the policy of the State to access to relevant quality education through the employment of an alternative learning system that would enable the youth including adults to overcome geographical, socioeconomic and/or physical constraints to their completion of secondary education.

SECTION 3. Definition of Terms - For the purposes of this Act, the following terms are hereby defined:

- a) *Open High School System* - a system of delivering educational services to high school students utilizing print, radio, television and computer-based communications, satellite broadcasting, teleconferencing, and other multimedia learning and teaching technologies that allow students to study on their own without having to regularly attend class in conventional classrooms.
- b) *Distance Learning Program* - an educational program whereby the teaching and learning processes are accomplished through self-instructional materials that allow independent study, multi-channel learning and school-family community partnership.
- c) *Inang Paaralan or Mother High School* - a regular secondary school in the regional or division level that functions, among others, as; 1) headquarters of the distance learners and teachers; 2) center for enrollment, evaluation, direct or face-to-face instruction and promotion of distance learners; 3) receiver of donations, instructional materials and such reports relative to distance learning; and 4) coordinator of the different learning centers in the community.
- d) *Guro* - a regular secondary school teacher of the “Inang Paaralan” who is in charge of direct instruction, evaluation of student progress and keeping of the records of individual learners.

- e) *Gurong Tagapatnmbay* - a regular secondary school teacher of the hang Paaralan who serves as guidance counselor to the distance learners; coordinates with the p r o and para guro in evaluating the students' progress; and prepares and submits reports to the authorities concerned.
- f) *Gurong Kadluan* - a resource person with specialized skills in practical or industrial subjects such as farming, handicraft, and auto-mechanics, tailoring and other skills.
- g) *Para Guro* - a degree holder or college level citizen resident in the community who manages a learning center and facilitates the learning process of a group of distance learners.
- h) *Tagapagpayong Pansamahan* - the adviser of a club in the community who helps earners harmonize study with community service and leisure.

SECTION 4. Institutionalization of the Open High School System. -to carry out the above-declared policy, the Open High School hereinafter referred to as the System is hereby institutionalized in the Philippines in accordance with the provisions of the Act.

SECTION 5. Coverage - This Act shall apply to public secondary educational institutions with existing distance learning programs and all other such institutions that shall later be authorized as qualified implementers of the System.

All existing programs and projects of the Bureau of Secondary Education regarding dropout intervention and poverty alleviation through education shall be part of the Open High School System.

SECTION 6. Clientele of the System - The System shall be open to all youth and adults who have finished elementary education and high school qualifiers of the Philippine Educational Placement Test (PEPT).

SECTION 7. Administration and Supervision - The Department of Education (DepEd) shall administer and supervise the System. An Open High School Unit shall be attached to the Bureau of Secondary Education (BSE) to assist the Bureau in performing the following functions:

- a. Formulate the objectives and basic policies of the System;
- b. Formulate , adopt and supplement programs that will make the System effective and productive;
- c. Monitor and evaluate existing distance learning programs for the integration with the system;
- d. Develop and validate prototype instructional distance learning materials;
- e. Consult and collaborate with other DepEd divisions, local government units &Gus), non-government organizations (NGOs) and other private agencies for the effective operation of the system;

- f. Promulgate the necessary guidelines, rules and regulations for the effective implementation of the System;
- g. Recommend to the DepEd the annual budget of the System for inclusion in the General Appropriations Act for the year; and
- h. Perform such other tasks as may be necessary to attain the objectives of the System.

SECTION 8. Establishment of Distance Learning Centers - Distance learning centers shall be established in the Inang Paaralan or in the community. The Center is a room of building where the distance learners can conduct researches or gather additional information on topics under study. It can also serve as a venue where the Gurong Kadluan can conduct hands-on exercises/activities.

SECTION 9. Collaboration between Department of Education (DepEd) and the Department of Interior and Local Government (DILG) - The DepEd and DILG shall sign a Memorandum of Agreement (MOA) defining the role of local government units in the operation of the system in order to ensure maximum collaboration between DepEd and local government units toward the success of the System.

SECTION 10. Role of Government Broadcast Stations and Telecommunication Networks - Government broadcast stations and telecommunication networks shall provide the necessary assistance and support to the System; Provided, that stations and networks shall also be encouraged to provide the same.

SECTION 11. Role of Parents. - Parents of distance learners shall be provided with adequate information on the System as well as for sharing experiences to enable them to completely assist their children their children in their distance learning.

SECTION 12. Personnel Recruitment and Incentives - all personnel involved in the System shall have adequate and appropriate education and training to be determined by the BSE-DepEd.

Teachers or Gurong Tagapatnubay shall receive incentives and/or monetary compensation as determined by the BSE-DepED while the Para Guro, Gurong Kadluan and Tagapayong Pansamahan shall receive honoraria, to be arranged with the local school board.

It shall be the duty of the local government units concerned to employ the Para Guro, Gurong Kadluan and Tagapayong Pansamahan in accordance with the guidelines on hiring such personnel prepared upon prior consultation with the BSE-DepED and issued by the same LGUs.

SECTION 13. Training on the System's Teachers - The open High School Unit attached to the Bureau of Secondary Education shall take charge of the training of the Guro, Gurong Tagapatnubay, Gurong Kadluan, Para Guro and Tagapayong Pansamahan.

The training of the Para Guro, Gurong Kadluan and Tagapayong Pansamahan shall be in coordination with the local government units and non-government organizations concerned.

SECTION 14. Curriculum Content. - The System shall adopt the National Secondary Education Curriculum (NSEC) using the Philippine Secondary Schools Learning Competencies (PSSLC).

The Open High School System Unit in collaboration with the curriculum Development Division, Bureau of Secondary Education (BSE) shall modify the herein adopted curriculum; devise a rating system, instructional strategies and material that will suit the psycho-social needs and physical condition of the conduct disordered and antisocial learners who are detained in correctional institutions. In the discharge of this function, the BSE shall consult with professional psychiatrists, psychologists, social workers and other related experts who manage or deal with youth offenders who are undergoing rehabilitation.

SECTION 15. Implementing Rules and Regulations. - The Department of Education, through the Curriculum Development Division of the Bureau of Secondary Education, upon prior consultation with the Committees on Education of the Senate and the House of Representatives, shall issue the necessary rules and regulations for the effective implementation of this Act within a period of ninety (90) days after its approval.

SECTION 16. Appropriations. - The amount necessary for the initial implementation of this Act shall be charged against the current year's appropriation of the Distance Learning Program of the BSE-DepED. Thereafter, such sums as may be necessary for its continued implementation shall be included in the annual General Appropriations Act.

SECTION 17. Separability Clause. - If any provision of this Act is declared invalid or unconstitutional, the other provisions not so declared shall remain in force and effect.

SECTION 18. Repealing Clause. - All laws, decrees, orders, rules and regulations or parts thereof inconsistent with this Act are hereby repealed or modified accordingly.

SECTION 19. Effectivity. - This Act shall take effect immediately upon its approval.
