EXPLANATORY NOTE

In recognition of the invaluable service being rendered by the members of the Armed Forces of the Philippines, Philippine National Police, Bureau of Fire Protection, and Bureau of Jail Management and Penology, this bill seeks to expand and maximize the scholarship grant to their families, as stipulated under Republic Act no. 6963, or "An Act Granting Special Financial Assistance and Benefits to the Family or Beneficiary of any Police or Military Personnel or Fireman Killed or Permanently Incapacitated While in the Performance of his Duty or by Reason of his Office or Position and for other purposes."

Aside from the family members of the deceased or permanently incapacitated members of AFP and PNP, this bill extends the scholarship grants to the family members of BJMP and BFP who were also killed or permanently incapacitated while in performance of his duty or by reason of his position or office, regardless of the length of service he has rendered. In addition, this measure includes in the coverage one family member of active personnel of AFP, PNP, BJMP, and BFP, rendering at least two years of service. This also provides additional funding source for the scholarship grants, as well as the creation of an Inter-agency Scholarship Board which will serve as a policy-making body that has the authority to provide mechanics on the implementation of the scholarship program.

In view of the foregoing, immediate passage of this bill is earnestly sought.

AN ACT

EXPANDING AND MAXIMIZING THE SCHOLARSHIP GRANTS EXTENDED TO THE FAMILY MEMBERS OF PERSONNEL OF THE PHILIPPINE NATIONAL POLICE (PNP), ARMED FORCES OF THE PHILIPPINES (AFP), BUREAU OF FIRE PROTECTION (BFP), PROTECTION (BFP), AND BUREAU OF JAIL MANAGEMENT AND PENOLOGY (BJMP), AMENDING FOR THIS PURPOSE CERTAIN PROVISIONS OF REPUBLIC ACT NO. 6963, ENTITLED "AN ACT GRANTING SPECIAL FINANCIAL ASSITANCE AND BENEFITS TO THE FAMILY OR BENEFICIARY OF ANY POLICE OR MILITARY PERSONNEL OR FIREMAN KILLED OR PERMANENTLY INCAPACITATED WHILE IN THE PEFROMANCE OF HIS DUTY OR BY REASON OF HIS OFFICE OR POSITION AND FOR OTHER PURPOSES"

Be it enacted by the Senate and the House of Representatives of the Philippines in Congress

assembled:

1 SECTION 1. Section 1 of Republic Act No. 6963 is hereby amended to read as follows: "Sec. 1. The family or beneficiary of any PERSONNEL OF THE PHILIPPINE 2 NATIONAL POLICE (PNP), ARMED FORCES OF THE PHILIPPINES (AFP), BUREAU 3 OF FIRE PROTECTION (BFP) AND BUREAU OF JAIL MANAGEMENT AND 4 5 PENOLOGY (BJMP) [police or military personnel, including any fireman assisting in a police or military action], who is killed or becomes permanently incapacitated while in the 6 7 line of duty or by reason of his office or position, provided he/she has not committed any crime or human rights violation by final judgment on such occasion, shall be entitled to the 8 9 special financial assistance provided for in this Act in addition to whatever compensation, 10 donation, insurance, gift, pension, grant, or any form of benefit which said deceased or 11 permanently incapacitated person or his/her family may receive or be entitled to." 12 13 SECTION 2. Section 2 of Republic Act No. 6963 is hereby amended to read as follows: 14 "Sec. 2. DEFINITION OF TERMS. AS USED IN THIS ACT THE 15 FOLLOWING SHALL REFER TO: 16 a. "PERSONNEL" - THE UNIFORMED PERSONNEL OF THE PNP, AFP, BFP, 17 AND BJMP;

 BOARD" - THE INTER-AGENCY SCHOLARSHIP BOARD HEREIN REFERRED TO AS THE UNIFORMED-PERSONNEL SCHOLARSHIP BOARD AS PROVIDED UNDER SECTION 10 OF THIS ACT;

c. the term "family" OR "BENEFICIARY" - [as used in this Act shall refer to] 4 The surviving legal spouse and his/her legitimate children, or parents, or brothers 5 and sister, or aunts and uncles, in that respective order: PROVIDED, THAT IF 6 THE PERSONNEL IS A SOLO PARENT, THE PERTINENT PROVISION OF 7 RA 8972 OR THE SOLO PARENT ACT SHALL APPLY. Provided FURTHER, 8 that, if the [police or military] personnel [or fireman] is ESPOUSING a MUSLIM 9 [Muslim] FAITH, the pertinent provisions of the Code of Muslim Personal Laws 10 -(Shari' a) shall apply; and 11

d. DEATH OR INJURY IN THE LINE OF DUTY - AS USED IN REFERENCE 12 TO THE DEATH OR INJURY SUFFERED BY ANY MEMBER OF THE PNP. 13 AFP. BFP. OR BJMP. THE PHRASE "IN THE LINE OF DUTY" SHALL BE 14 CONSTRUED TO MEAN THAT THE DEATH OR INJURY WAS CAUSED 15 WHILE IN THE PERFORMANCE OF ANY POLICE, MILITARY, FIRE OR 16 JAIL DUTY AND OPERATION, AS THE CASE MAY BE, OR BY REASON 17 OF THEIR POSITION. PROVIDED, THAT, WHERE THE DEATH OR 18 INJURY (I WAS DUE TO HIS/HER OWN ACT, THE LATTER MUST BE 19 LAWFUL AND SUCH DEATH OR INJURY MUST NOT BE SELF-20 INFLICTED OR ABETTED BY HIS/HER GROSS NEGLIGENCE. 21 ALCOHOLISM, DRUG ADDICTION, OR ABUSE OF AUTHORITY, 22 PROVIDED, FURTHER, THAT THE PHRASE "LINE OF DUTY" SHALL 23 INCLUDE GOING TO AND COMING FROM HIS/HER OFFICE OR ON 24 ADMINISTRATIVE MISSION. PROVIDED, FINALLY, THAT ANY DOUBT 25 AS TO WHETHER OR NOT THE DEATH OR INJURY SUSTAINED BY 26 ANY PNP, AFP, BFP, OR BJMP PERSONNEL IS IN THE LINE OF DUTY OR 27 BY REASON OF HIS/HER OFFICE OR POSITION SHALL BE DECIDED IN 28 HISHER FAVOR." 29

SEC. 3. Section 3 of Republic Act No. 6963 is hereby amended to read as follows:

"Sec. 3. The special financial assistance referred to in Section one hereof shall be that which is equivalent to the average six (6) months salary, including allowances and bonuses, during the last twelve (12) months preceding the death or permanent incapacity of the PERSONNEL [officer] which shall not be considered as part of the estate of the deceased and which shall be exempt from attachment, garnishment or execution and from income and other taxes."

SEC. 4. Section 4 of Republic Act No. 6963 is hereby amended to read as follows:

į.

"Sec. 4. It shall be the duty of the cashier from whom the deceased PERSONNEL OF THE POLICE, MILITARY, FIRE OR JAIL BUREAU for permanently incapacitated police or military personnel or fireman] used 'to receive his/her salary, within three (3) days from receipt of a written certification from the station or unit commander of the fact of death and the circumstances thereof, to deliver to the beneficiaries such special financial assistance as stated in Section Three hereof. In case of permanent disability, a certification by the proper medical officer designated by the CHIEF OF THE PNP, OR the CHIEF OF STAFF OF THE AFP, OR THE CHIEF OF THE BFP, OR THE CHIEF OF THE BJMP, [the Chief of Staff of the Armed Forces of the Philippines or the Director General of the Integrated National Police] as the case may be, is necessary for the payment of the aforesaid special financial assistance. After said payment, a report with the formal certificate of death or permanent incapacity shall be submitted to the CHIEF OF THE PNP, OR the CHIEF OF STAFF OF THE AFP, OR THE CHIEF OF THE BFP, OR THE CHIEF OF THE BJMP [Secretary of National Defense or the Director General of the Integrated National Police]."

SEC, 5. Section 5 of Republic Act No, 6963 is hereby amended to read as follows:

"Sec. 5. In order to assure the payment of the special financial assistance 21 referred to in this Act, without any need of any appropriation act or ordinance, the 22 payment shall come from the expected salary, allowances and bonuses of the 23 deceased or permanently incapacitated POLICE, MILITARY, FIRE OR JAIL 24 PERSONNEL [police or military personnel or fireman] for the next six (6) 25 months after his/her death or permanent incapacity: Provided That, the position 26 left vacant by the deceased or permanently incapacitated POLICE, MILITARY, 27 FIRE OR JAIL PERSONNEL [police or military personnel or fireman] on 28 account of his/her death incapacity shall not be filled during that period of six (6) 29 months: Provided, further, That if the public welfare and interest so demand, as 30 determined by the CHIEF OF THE PNP, IN THE CASE OF POLICE 31 32 PERSONNEL; OR THE CHIEF OF STAFF OF THE AFP, IN CASE OF MILITARY PERSONNEL; OR THE CHIEF OF THE BFP, IN THE CASE OF 33 FIRE PERSONNEL; OR THE CHIEF OF THE BJMP, IN THE CASE OF JAIL 34 PERSONEL, [municipal or city mayor or provincial governor, in the case of a 35 police personnel or fireman, or the Secretary of National Defense, in the case of 36 military personnel] the position left vacant by the deceased or permanently 37

incapacitated personnel may be filled without waiting for the expiration of the six months period earlier mentioned in which case, the funds out of which the special financial assistance already received by the family of the deceased or permanently incapacitated personnel shall be replenished out of the emergency savings of the CONCERNED BUREAU, UPON THE DIRECTION IN WRITING BY THEIR CHIEFS OR DIRECTORS [municipality, city or province, or the department, upon the direction in writing by the municipal or city mayor or governor of the province, department secretary,] to their respective treasurers or cashiers. [Provided, finally, That, in the event of such emergency, no emergency savings as provided herein exist, the regional commander or the provincial commander, as the case may be, may draw augmentation personnel from any municipality in the province or region to fill up the vacancy until such time that the municipality where the vacancy occurred can fill up such vacancy with regular personnel.]"

Sec 6. Section 6 of Republic Act No. 6963 is hereby amended to read as follows:

"Sec. 6. If any POLICE, MILITARY, FIRE OR JAIL PERSONNEL
[police or military personnel or fireman] is injured or wounded while in the
performance of his/her official duties, the hospitalization expenses of such [police
or military] personnel [or fireman] shall be shouldered by the office where he/she
belongs, chargeable against the salary savings of such office without the need of
any appropriation act or ordinance."

Sec. 7. Section 7 of Republic Act No. 6963 is hereby amended to read as follows:

"Sec. 7. [The surviving spouse] ONE OF THE BENEFICIARIES of the deceased or permanently incapacitated POLICE, MILITARY, FIRE OR JAIL PERSONNEL [police, military, fire or jail personnel] shall be given priority in employment in a government agency or office where his/her qualifications are fitted. [: Provided that, if the spouse is already employed or not employable or if he/she waives his/her employment privilege, then an employable son or daughter shall be granted the said privilege.]"

Sec. 8. Section 8 of Republic Act No. 6963 is hereby amended to read as follows:
"Sec. 8. A MAXIMUM OF FOUR (4) CHILDREN OF THE DECEASED
OR PERMANENTLY INCAPACITATED POLICE, MILITARY, FIRE OR
JAIL PERSONNEL, REGARDLESS OF THE LENGTH OF SERVICE, SHALL
BE EXTENDED SCHOLARSHIP UP TO COLLEGE IN AN EDUCATIONAL
INSTITUTION AS MAY BE DETERMINED BY THE BOARD, SUBJECT TO

THE POLICIES ON THE TUITION OF SAID INSTITUTION: PROVIDED 1 THAT, ONLY ONE (1) CHILD OF PERSONNEL IN ACTIVE DUTY WHO 2 SERVED FOR AT LEAST TWO (2) YEARS PRIOR TO THE DATE OF 3 APPLICATION FOR GRANT MAY BE ENTITLED TO THE SCHOLARSHIP; 4 PROVIDED, FURTHER, THAT, IN CASES OF SINGLE AND/OR 5 UNMARRIED PERSONNEL, THE SCHOLARSHIP SHALL BENEFIT ONLY 6 ONE (1) AMONG THE OTHER ENUMERATED BENEFICIARIES AS 7 DEFINED IN THIS ACT. - PRIORITY TO THE SCHOLARSHIP OF ALL QUALIFIED CHILDREN OF 10 THE DECEASED OR PERMANENTLY INCAPACITATED PERSONNEL; 11 PROVIDED, FINALLY, THAT THE SCHOLARSHIP SHALL INCLUDE 12 PAYMENT OR EXPENSES FOR TUITION, MISCELLANEOUS AND 13 OTHER FEES, AS WELL AS COST OF BOOKS AND OTHER MATERIALS. 14 [All surviving children of the deceased or permanently incapacitated police or 15 military personnel or fireman shall be extended scholarship up to college in a 16 nonexclusive institution, subject to the policies on tuition of said institution. The 17 scholarship privilege shall be limited to the National Police Commission or the 18 Department of National Defense, as the case maybe, upon presentation to it of the 19 approved enrollment or registration form.]" 20

- " SEC. 9. Section 9 of Republic Act No. 6963 is hereby amended to read as follows:

Sec. 9. TO FINANCE AND SUPPORT THE SCHOLARSHIP GRANTS 23 HEREIN PROVIDED; THE NET PROCEEDS OF THE 0 FIREARMS 24 LICENSE FEES COLLECTED BY THE FIREARMS AND IO EXPLOSIVES 25 OFFICE OF THE PHILIPPINE NATIONAL POLICE, FIFTEEN PERCENT 26 (15%) OF THE FIRE CODE FEES COLLECTED PURSUANT TO PD 1185, A 27 MAXIMUM OF FIVE PERCENT (5%) OF THE STATE SCHOLARSHIP OF 28 THE DEPARTMENT OF EDUCATION PURSUANT TO RA 6728, AND TEN 29 PERCENT (10%) OF THE COMMISSION ON HIGHER EDUCATION (CHED) 30 SCHOLARSHIP FUND PURSUANT TO RA 7722 TO BE SET ASIDE FOR 31 THE TERTIARY LEVEL SCHOLARSHIP GRANT, SHALL BE REMITTED 32 DIRECTLY TO THE BOARD. Sec. 10. Section 11 of Republic Act No. 6963 is hereby amended to read as follows:

"SEC. 11. The SCHOLARSHIP funds collected HEREIN [from the firearms licensing fees] shall be MANAGED AND ADMINISTERED BY AN 23 INTER-AGENCY SCHOLARSHIP BOARD TO BE KNOWN AS THE 24 UNIFORMED-PERSONNEL SCHOLARSHIP BOARD. THE BOARD SHALL 25 BE COMPOSED OF THE SECRETARY OF THE DEPARTMENT OF THE 26 IINTERIOR AND LOCAL GOVERNMENT AND SECRETARY OF THE 27 DEPARTMENT OF NATIONAL DEFENSE AS CO-CHAIRMEN AND FOUR 28 (4) MEMBERS TO REPRESENT THE PNP, AFP, BFP AND BJMP. THE 29 BOARD SHALL SERVE AS THE POLICY MAKING BODY TO BE VESTED 30 WITH THE AUTHORITY TO COME-UP WITH THE MECHANICS AND 31 REQUIREMENTS FOR SCHOLARSHIP PROGRAM IN ATTAINING THE 32 OBJECTIVES OF THIS ACT. THE BOARD SHALL HAVE THE AUTHORITY TO ACCEPT 3 DONATIONS, CONTRIBUTIONS, GRANTS IN CASH OR IN KIND, FROM 4 VARIOUS SOURCES, DOMESTIC OR FOREIGN. SAID DONATIONS 5 SHALL BE USED EXCLUSIVELY TO COMPLEMENT THE FUNDING 6 REOUIREMENTS OF THE SCHOLARSHIP PROGRAM SUBJECT TO THE 7 EXISTING GOVERNMENT ACCOUNTING AND AUDITING RULES AND 8 REGULATIONS: PROVIDED, THAT ANY DONATION, CONTRIBUTION 9 OR FINANCIAL AID WHICH MAY BE MADE TO THE BOARD SHALL BE 10 EXEMPT FROM TAXES OF ANY KIND AND SHALL CONSTITUTE 11 ALLOWABLE DEDUCTIONS IN FULL FROM THE INCOME OF THE 12 DONORS, CONTRIBUTORS OR GIVERS FOR INCOME TAX PURPOSES. 13 FURTHERMORE, THE BOARD IS AUTHORIZED TO INVEST SO MUCH 14 OF THE FUND FOR THE PURPOSE OF GENERATING ADDITIONAL 15 REVENUE FOR THE BENEFIT OF THE SCHOLARSHIP PROGRAM. 21	publication in two (2) newspapers circulation. Beneficiaries who reach the age of majority and
22	remains unmarried while enjoying the benefits of this Act but have not completed their
23	secondary education shall continue to be entitled to the benefits until they complete secondary
24	school.
