## Introduced by Sen. Antonio "Sonny" F. Trillanes IV

### **Explanatory Note**

In the 1993 case of Oposa v, Factoran<sup>1</sup> the Supreme Court recognized the concept of intergenerational equity, upholding the rights of minors to sue for the judicious management of our country's forests and the necessity of maintaining a sound ecological balance and protecting and enhancing the quality of the environment in accordance with Sections 15 and 16, Article II of the 1987 Constitution.

Recognizing that a system of inter-generational equity involving both rights and responsibilities may be substantially more effective in achieving the twin goals of environment protection and sustainable development, this bill seeks to impose a positive duty upon all graduating elementary, high school and college students to plant at least ten (10) trees as a prerequisite for graduation, These trees shall be their legacy to the environment and to fnture generations.

Indeed, while we recognize the right of the youth to a balance and healthful ecology, as proclaimed in the 1987 Constitution, there is no reason why they Calillot be made to contribute in order to ensure that this would be an actual reality.

With over 12 Million students graduation from elementary and nearly 5 Million students graduation from high school<sup>2</sup> and almost  $500,000^3$  graduating from college each year, this initiative, if properly implemented, will ensure that at least 175 Million new trees would be planted each year. In the course of one generation,<sup>4</sup> no less than 525 Billion trees can be planted under this initiative, Even with a survival rate of on ten percent (10%), tins would mean an additional 525 Million trees would be available for the youth to enjoy, when they assume the mantle of leadership in the future.

This bill also aims to complement Executive Order No, 26, Series of 2011, issued by his Excellency, President Benigno S, Aquino III, which aims to mobilize students and government employees to plant 1.5 Billion trees over a period of six (6) years, from 2011 to 2016.

In view of the foregoing, immediate passage of this bm is earnestly requested.

SEC. 2. Declaration of Policy .- It is hereby declared the policy of the State to promote 4 and pursue environmental protection and sustainable development for poverty reduction, food 5 security, biodiversity conservation, and climate change mitigation and adaptation. 6

SEC. 3. Tree-planting as a Mandatory Requisite for Graduation .- Pursuant to the policy 8 of the state to promote and pursue environmental protection and sustainable development, all 9 graduating grade-school or primary education (Grade 6 or 7) students, high school or secondary 10 education (4th Year High School) students, as well as all college or university students shall be 11 required to plant at least ten (10) trees as a mandatory prerequisite for their graduation. Said trees 12 shall be their living legacy to the environment and to future generations of Filipinos. 13

### **REQUIRING ALL GRADUATING ELEMENTARY, HIGH SCHOOL AND COLLEGE** STUDENTS TO PLANT AT LEAST TEN (10) TREES EACH AS A PREREQUISITE FOR GRADUATION AND FOR OTHER RELATED PURPOSES

Be it enacted by the Senate and the House of Representatives of the Philippines in Congress assembled:


SECTION 1. Short Title. - This act shall be known as the "Graduation Legacy for the

11	SEC. 7. Funding Mechanisms Funds needed for the implementation of this Act for the
12	current year shall be provided by the DBM and funding for the succeeding years shall be
13	incorporated in the regular appropriation of participating agencies.
14	
15	SEC. 8. Separability Clause Any portion or provision of this Act that maybe declared
16	unconstitutional shall not have the effect of nullifying other provisions hereof, as long as such
17	remaining portions can still subsist and can be given effect in their entirety.
18	
19	SEC. 9. Repealing Clause All rules and regulations and other issuances or parts
20	thereof, which are inconsistent with this Act are hereby amended, repealed or modified
21	accordingly.
22	
23	SEC. 10. Effectivity This Act shall take effect within sixty (60) days upon its
24	publication in at least two (2) newspapers of general circulation of the Official Gazette.
