

EXPLANATORY NOTE

Executive Order No. 292, or the "Administrative Code of 1987," Title 13, Chapter 1,

Section 1, provides:

The State shall promote, encourage and develop tourism as a major national activity in which private sector investment, effort and initiative are fostered and supported, and though which socio-economic development may be accelerated, foreign exchange earned, international visitors offered the opportunity to travel to the Philippines and appreciate its natural beauty, history and culture, and Filipinos themselves enabled to see more or their country and imbued with greater pride in and commitment to the nation.

The tourism industry contributes to the economic growth of our country by generating

foreign exchange earnings, employment opportunities and international goodwill. It also

promotes the rich and colorful socio-cultural life of the Filipino people.

In order to realize the full potential of tourism as an important economic tool necessary

for national development, the government should adopt and implement an integrated approach to

tourism development.

Hence, this bill seeks to establish an intergovernmental task force for international visitor

assistance to make the Philippines a premier travel and tourism destination in the world.*

AN ACT ESTABLISHING AN INTERGOVERNMENTAL TASK FORCE FOR INTERNATIONAL VISITOR ASSISTANCE

Be it enacted by the Senate and the House of Representatives of the Philippines in Congress assembled:

SECTION 1. Short Title. - This Act shall be known as the "Visit Philippines Act."

2 SECTION 2. International Visitor Assistance Task Force. -

3 (A) ESTABLISHMENT - Not later than ninety (90) days after the enactment of this
4 Act, the Secretary of Tourism shall establish an Intergovernmental Task Force for International
5 Visitor Assistance (hereinafter referred to as the "Task Force").

6 (B) DUTIES - The Task Force shall examine -

1

- 7 (1) signage at facilities in the Philippines, including airports, seaports, land
 8 border crossings, highways, and bus, train, and other public transit
 9 stations, and shall identify existing inadequacies and suggest solutions for
 10 such inadequacies, such as the adoption of uniform standards on signage
 11 for use throughout the Philippines in order to facilitate international
 12 visitor's travel in the Philippines;
- 13 (2) the availability of multilingual travel and tourism information and means
 14 of disseminating, at no or minimal cost to the government, of such
 15 information; and
- 16 (3) facilitating the establishment of a toll-free, private-sector operated,
 17 telephone number, staffed by multilingual operators, to provide assistance
 18 to international tourists coping with an emergency.

(C) MEMBERSHIP - The Task Force shall be composed of the following members: 1 2 (1)The Secretary of Tourism; The Secretary of Interior and Local Government; 3 (2)4 (3) The Secretary of Transportation and Communications; 5 (4) Such other representatives of other government agencies and privatesector entities as may be determined to be appropriate to the mission of the 6 7 Task Force by the Chair. CHAIR - The Secretary of Tourism shall be the Chair of the Task Force. The 8 (D) Task Force shall meet at least twice each year. Each member of the Task Force shall furnish 9 necessary assistance to the Task Force. 10

11 (E) REPORT - Not later than eighteen (18) months after the date of the enactment of 12 this Act, the Chair of the Task Force shall submit to the President and to Congress a report on the 13 results of the review, including proposed amendments to existing laws or regulations as may be 14 appropriate to implement such recommendations.

15 SECTION 3. Funding. -

16 (A) AUTHORIZATION - Subject to subsection (B), there are authorized to be 17 appropriated such sums as may be necessary for the purpose of funding promotional activities by 18 the Department of Tourism to help brand, position, and promote the Philippines as a premier 19 travel and tourism destination in the world.

(B) RESTRICTIONS ON USE OF FUNDS - None of the funds appropriated under
 subsection (A) may be used for purposes other than marketing, research, outreach, or any other
 activity designed to promote the Philippines as the premier travel and tourism destination in the
 world.

24 SECTION 4. *Report to Congress.* - The Secretary shall submit to the relevant 25 Committees of Congress an annual detailed report setting forth -

- (A) the manner in which appropriated funds were expended;

1 (B) changes in the Philippine market share of international tourism in general and as 2 measured against specific countries and regions;

3 (C) an analysis of the impact of international tourism on the Philippine economy, 4 including, as specifically as practicable, an analysis of the impact of expenditures made pursuant 5 to this Act;

6 (D) an analysis of the impact of international tourism on the Philippine trade balance 7 and, as specifically as practicable, an analysis of the impact on the trade balance of expenditures 8 made pursuant to this Act; and

9 (E) an analysis of other relevant economic impacts as a result of expenditures made 10 pursuant to this Act.

11 SECTION 5. *Separability Clause*. - If any provision or part hereof is held invalid or 12 unconstitutional, the remainder of the law or the provision not otherwise affected shall remain 13 valid and subsisting.

14 SECTION 6. *Repealing Clause.* - Any law, presidential decree or issuance, executive 15 order, letter of instruction, administrative order, rule, or regulation contrary to or inconsistent 16 with the provisions of this Act is hereby repealed, modified, or amended accordingly.

SECTION 7. *Effectivity Clause*. - This Act shall take effect fifteen (15) days after its
publication in at least two (2) newspapers of general circulation.
