**MR. PRESIDENT:**

The Committee on Finance to which was referred **S.B. No. 1509**, introduced by **Senator Jinggoy P. Ejercito-Estrada**, *entitled:*

**“AN ACT  
AMENDING REPUBLIC ACT 9184, OTHERWISE KNOWN AS THE  
‘GOVERNMENT PROCUREMENT REFORM ACT’, WITHDRAWING  
FROM ITS APPLICATION ALL REFERENCES TO THE LOCAL  
GOVERNMENT UNITS”**


