Re: Senate Bill No. 1386

Recommending its approval with amendments.

**MR. PRESIDENT:**

The Committees on Labor, Employment and Human Resources Development; Local Government; and Finance to which was referred S. No. 1386, introduced by Senator Jinggoy Ejercito Estrada, entitled:

**"AN ACT  
DEFINING THE ROLE OF THE DEPARTMENT OF LABOR AND EMPLOYMENT (DOLE) AND THE LOCAL GOVERNMENT UNITS (LGUS) IN THE ESTABLISHMENT AND OPERATION OF THE PUBLIC EMPLOYMENT SERVICE OFFICE (PESO), AND THE OPERATION OF JOB PLACEMENT OFFICE IN SUCS AND NGOS, AMENDING FOR THE PURPOSE SECTIONS 3, 6, 7, AND 9 OF REPUBLIC ACT NO. 8759, OTHERWISE KNOWN AS PUBLIC EMPLOYMENT SERVICE OFFICE ACT OF 1999"**

have considered the same and have the honor to report it back to the Senate with the recommendation that the bill be approved with the following amendments:

1. On page 1, line 6, before the word "and", insert the word "FIRST";
2. On the same page and the same line, after the word "and", insert the words "SECOND CLASS";

3. On the same page, line 7, after the word "municipalities", insert the phrase

"AND OTHER STRATEGIC AREAS AS MAYBE DETERMINED BY THE DEPARTMENT OF LABOR AND EMPLOYMENT (DOLE) AND THE LOCAL GOVERNMENT UNIT (LGU),";

4. Finally, on page 3, delete line 46 to 55, and insert two paragraphs to read as follows:


"THE LGUS SHALL PROVIDE FUNDING FOR THE OPERATION AND MAINTENANCE OF ITS PESO FROM THE INTERNAL REVENUE ALLOTMENT AND OTHER INTERNALLY GENERATED INCOME OF THE LGU CONCERNED. LIKewise, THE OPERATION AND MAINTENANCE OF THE JOB PLACEMENT OFFICES OF NGOS AND SUCS SHALL BE CHARGED AGAINST THEIR INTERNALLY GENERATED INCOME. IN NO CASE SHALL NGOS AND SUCS BE PROVIDED FUNDING BY THE NATIONAL GOVERNMENT FOR THE OPERATION AND MAINTENANCE OF THEIR RESPECTIVE JOB PLACEMENT OFFICES.

"FOR THE DOLE, FUNDS FOR THE PROVISION OF TECHNICAL ASSISTANCE, TRAINING AND SUPERVISION OF THE PESO SHALL BE INCLUDED IN THE BUDGET OF THE DOLE IN THE ANNUAL GENERAL APPROPRIATION ACT.


