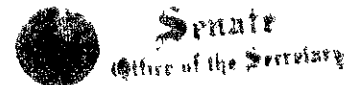

CORRUPT PRACTICES ACT, AMENDING SECTION 11 THEREOF"**


