- AN ACT INCREASING THE CEILING FOR THE TOTAL EXCLUSION FROM GROSS INCOME OF 13TH MONTH PAY AND OTHER BENEFITS TO SEVENTY THOUSAND PESOS (P70,000). AMENDING FOR THE PURPOSE SECTION 32(B)(7)(E) OF THE NATIONAL INTERNAL REVENUE CODE OF 1997, AS AMENDED

Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:

1	SECTION 1. Section 32(B)(7)(e) of the National Internal Revenue Code
2	of 1997, as amended, is hereby further amended to read as follows:
3	"SEC. 32. Gross Income. –
4	"(A) x x x
5	"(B) Exclusions from Gross Income The following
6	items shall not be included in gross income and shall be exempt
7	from taxation under this Title:

2	"(7) Miscellaneous Items. –

4	"(e) 13 th Month Pay and Other Benefits. – Gross
5	benefits received by officials and employees of public and
6	private entities: Provided, however, That the total exclusion
7	under this subparagraph shall not exceed [Thirty thousand pesos
8	(P30,000)] SEVENTY THOUSAND PESOS (P70,000) which shall
9	cover:

13	"(iv) Other benefits such as productivity incentives and
14	Christmas bonus: Provided, further, That the ceiling of [Thirty
15	thousand pesos (P30,000)] SEVENTY THOUSAND PESOS

17	regulations issued by the Secretary of Finance, upon
18	recommendation of the Commissioner, after considering, among
19	others, the effect on the same of the inflation rate at the end of
20	the taxable year."
21	SEC. 2. Implementing Rules and Regulations The Secretary of
22	Finance shall, upon the recommendation of the Commissioner of Internal

Finance shall, upon the recommendation of the Commissioner of Internal
Revenue, promulgate the necessary rules and regulations for the effective
implementation of this Act.

SEC. 3. Repealing Clause. - All laws, acts, presidential decrees,
 executive orders, issuances, presidential proclamations, rules and regulations

or parts thereof which are contrary to and inconsistent with any of the
 provisions of this Act are hereby repealed, amended or modified accordingly.

3 SEC. 4. *Effectivity.* - This Act shall take effect fifteen (15) days after
4 its complete publication either in the *Official Gazette* or in at least two (2)
5 newspapers of general circulation.
