

AN ACT AMENDING SECTION 28 OF REPUBLIC ACT NO. 9147, ALSO KNOWN AS THE WILDLIFE RESOURCES CONSERVATION AND PROTECTION ACT

The Constitution, Article 2, Section 16 provides:


"Section 16. The State shall protect and advance the right of the people to a balanced and healthful ecology in accord with the rhythm and harmony of nature."

Early this year, it was reported that several Chinese fishermen were captured with 500 live and dead turtles in their boat, 60 nautical miles from Palawan. The fishermen were arrested and charged for violating the Philippine Wildlife Act and Philippine Fisheries Code. In November 2014, the regional trial court of Palawan found them guilty and ordered each fisherman to pay a fine of \$100,000 each for poaching in Philippine waters plus \$\text{P}\$120,000 (\$2,666) each for taking wildlife. Despite the seemingly hefty fine, the penalty is still not commensurate to the damage they have done to Philippine wildlife. Among the 500 turtles seized, several were female. The death of female sea turtles could hamper the population growth of this endangered species.

According to news reports, sea turtles are considered valuable in other countries and are sold at high prices despite being endangered species. This bill seeks to strengthen the Wildlife Resources Conservation and Protection Act by increasing the penalties for those who kill, traffic, or sell, among others, Philippine wildlife.

	Be it enacted by the Senate and the House of Representatives of the Philippines in Congress assembled:

4	SECTION 1. Section 28 of Republic Act No. 9147, also known as the Wildlife
5	Resources Conservation and Protection Act, is hereby amended to read as follows:
6	"Section 28. Penalties for Violations of this Act

8	For illegal acts under paragraphs (c) and (d) of the immediately
9	preceding section, an imprisonment of one (1) month to eight (8) years
10	[SIX (6) MONTHS TO TWELVE (12) YEARS] and/or a fine of five
11	thousand pesos (\$\mathbb{P}5,000.00) to Five million pesos (\$\mathbb{P}5,000,000.00) shall be
12	imposed.
13	For illegal acts under paragraph (e), the following penalties and/or
14	fines shall be imposed:
15	a. imprisonment of two (2) years and one (1) day to four (4)
16	years [FOUR (4) YEARS AND ONE (1) DAY TO SIX (6) YEARS]
17	and/or a fine of Five thousand pesos (\$\frac{1}{2}\$5,000.00) to \$\frac{1}{2}\$ Three hundred thousand
18	pesos (P300,000.00) [TWO MILLION (P2,000,000.00) PESOS], if
19	inflicted or undertaken against species listed as critical;

1	b. imprisonment of one (1) year and one (1) day to two (2) years
2	[TWO (2) YEARS AND ONE (1) DAY TO FOUR (4) YEARS] and/or a
3	fine of Two thousand pesos (\$\mathbb{P}2,000.00) to Two hundred thousand pesos
4	(P200,000.00) [ONE MILLION (P1,000,000.00) PESOS], if inflicted or
5	undertaken against endangered species;
6	c. imprisonment of six (6) months and one (1) day to one (1)
7	year [ONE (1) YEAR AND ONE (1) DAY TO TWO (2) YEARS] and/or
8	a fine of One thousand pesos (\$\mathbb{P}1,000.00) to One-hundred thousand-pesos
9	(₱100,000.00) [FIVE HUNDRED THOUSAND (₱500,000.00) PESOS],
10	if inflicted or undertaken against vulnerable species;
11	d. imprisonment of one (1) month and one (1) day to six (6)
12	months [SIX (6) MONTHS AND ONE (1) DAY TO ONE (1) YEAR]
13	and/or a fine of Five hundred pesos (£500.00) to Fifty-thousand pesos
14	(₽50,000.00) [ONE HUNDRED THOUSAND (₽100,000.00) PESOS], if
15	inflicted or undertaken against species listed as threatened species; and
16	
17	For illegal acts under paragraphs (f) and (g) of the immediately
18	preceding section, the following penalties and/or fines shall be imposed:
19	a. imprisonment of two-(2) years and one (1) day to four (4)
20	years and a fine of Thirty thousand pesos (P30,000.00) to Three hundred
21	thousand pesos (P300,000.00) [SIX YEARS AND ONE DAY TO
22	TWELVE YEARS AND A FINE OF FIVE HUNDRED THOUSAND
23	PESOS (₱500,000) TO TEN MILLION PESOS (₱10,000,000)], if

inflicted or undertaken against species listed as critical;

b. imprisonment of one (1) year and one (1) day to two (2) years and a fine of Twenty thousand pesos (P20,000.00) to Two hundred thousand pesos (P200,000.00) [FOUR (4) YEARS AND ONE DAY TO SIX YEARS AND A FINE OF ONE HUNDRED THOUSAND PESOS (P100,000) TO FIVE MILLION PESOS (P5,000,000)], if inflicted or undertaken against endangered species;

- c. imprisonment of six (6) months and one (1) day to one (1) year and a fine of Ten thousand pesos (P10,000.00) to One hundred thousand pesos (P100,000.00) [ONE (1) YEAR AND ONE (1) DAY TO TWO (2) YEARS AND A FINE OF TWENTY THOUSAND PESOS (P20,000.00) TO FIVE HUNDRED THOUSAND PESOS (P500,000.00)], if inflicted or undertaken against vulnerable species;
- d. imprisonment of one (1) month and one (1) day to six (6) months and a fine of Five thousand pesos (P5,000.00) to Fifty thousand pesos (P50,000.00) [SIX (6) MONTHS AND ONE (1) DAY TO ONE (1) YEAR AND A FINE OF TEN THOUSAND PESOS (P10,000.00) TO ONE HUNDRED THOUSAND PESOS (P100,000.00)], if inflicted or undertaken against species as other threatened species; and
- e. imprisonment of ten (10) days to one (1) month and a fine of One thousand pesos (P1,000.00) to Five thousand pesos (P5,000.00) [ONE (1) MONTH AND ONE (1) DAY TO SIX (6) MONTHS AND A FINE OF FIVE THOUSAND PESOS (P5,000.00) TO FIFTY THOUSAND PESOS (P5,000.00)], if inflicted or undertaken against other wildlife species: Provided, That in case of paragraph (f), where the acts were perpetuated through the means of inappropriate techniques and devices, the

1	maximum penalty herein provided shall be imposed. PROVIDED
?	FURTHER, THAT IF THE ACTS WERE PERPETUATED BY A
3	SYNDICATE OR A GROUP OF THREE OR MORE PEOPLE,
4	THEN THE MAXIMUM PENALTY HEREIN PROVIDED SHALL
5	ALSO BE IMPOSED.

The fines herein prescribed shall be increased by at least ten percent

[10%] [TWENTY PERCENT (20%)] every three (3) years to compensate

for inflation and to maintain the deterrent function of such fines."

SECTION 2. Repealing Clause. - Any law, presidential decree or issuance, executive order, letter of instruction, administrative order, rule or regulation contrary to or inconsistent with, the provisions of this Act is hereby repealed, modified, or amended accordingly.

SECTION 3. *Effectivity Clause*. - This Act shall take effect fifteen (15) days after its publication in at least two (2) newspapers of general circulation.
