**AN ACT ESTABLISHING POLYTECHNIC UNIVERSITY OF THE
PHILIPPINES- SABLAYAN CAMPUS IN THE MUNICIPALITY OF SABLAYAN,
OCCIDENTAL MINDORO TO BE KNOWN AS "PUP- SABLAYAN CAMPUS"
APPROPRIATING FUNDS THEREOF AND FOR OTHER PURPOSES.**

EXPLANATORY NOTE

The 1987 Philippine Constitution Section 1, Article XIV provides that,

"The State shall protect and promote the right of all citizens to quality education at all levels, and shall take appropriate steps to make such education accessible to all."

Furthermore, Section 11 of Presidential Decree No. 1341 (Charter Creating the Polytechnic University of the Philippines) provides,

"It shall be the concern of the University to disperse its programs in the countryside through a system of regional branches."

The Polytechnic University of the Philippines (PUP) Sablayan campus located in Occidental Mindoro has been in operation for four years now under a Memorandum Agreement (MOA). Under the MOA, the local government of Sablayan shall fund all expenses for its operations.

With the passage of this legislative measure, the expenses for the operation of the university shall be charged to the National Government General Appropriations Act (GAA) which in return will lessen the expenditures of the local government unit concerned.

In view of the foregoing, the approval of this bill is hereby earnestly sought.

INTRODUCED BY SENATOR JOSEPH VICTOR G. EJERCITO

1 **AN ACT ESTABLISHING POLYTECHNIC UNIVERSITY OF THE**
2 **PHILIPPINES- SABLAYAN CAMPUS IN THE MUNICIPALITY OF SABLAYAN,**
3 **OCCIDENTAL MINDORO TO BE KNOWN AS "PUP- SABLAYAN CAMPUS"**
4 **APPROPRIATING FUNDS THEREOF AND FOR OTHER PURPOSES.**

6 *Be it enacted by the Senate and the House of Representatives of the Philippines in Congress*
7 *assembled;*

8
9 **SECTION 1.** This Act shall be known as the *"PUP- Sablayan Campus Act"*

10
11 **SECTION 2.** It is hereby declared by the State to provide accessible, quality and
12 affordable education to all. PUP System, since it was created proves the same.

13
14 **SECTION 3.** The PUP Sablayan Campus shall offer graduate, undergraduate and
15 short- term technical courses within the areas of specialization and according to its
16 capabilities, as the Board of Regents may deem necessary to carry out its objectives,
17 particular in order to meet the needs of the province and the region. The University
18 Campus is also mandated to undertake research and extension services, and
19 provides progressive leadership in these areas, includes the offering of post graduate
20 degrees under the Open University System.

21
22 **SECTION 4.** The University shall have the general powers of a corporation set forth
23 in the Corporation Law. The administration of the University and the exercise of its
24 powers shall be vested exclusively in the Board of Regents of the Polytechnic
25 University of the Philippines.

26
27 **SECTION 5.** The University Campus shall provide a scholarship program and other
28 affirmative action programs to assist poor but deserving students to qualify for
29 admission to the University.

30
31 No student shall be denied admission to the University Campus by reason of sex,
32 religion, cultural or community affiliation or ethnic origin.

33
34 **SECTION 6.** The University Campus shall enjoy academic freedom. University
35 Campus faculties, staff and students religious belief shall be respected at all times.

1 **SECTION 7.** On or before the fifteenth of the second month after the opening of the
2 regular class each year, the Board shall file with both Houses of Congress a detailed
3 report on the progress, conditions and needs of the PUP Sablayan Campus.
4

5 **SECTION 8.** The amount necessary to carry out the provisions of this Act shall be
6 charged against the current year's appropriations of the Polytechnic University of
7 the Philippines. Thereafter, such sums as may be necessary for the continued
8 operation and maintenance of the PUP shall be included in the annual General
9 Appropriations Act.
10

11 **SECTION 9.** In coordination with the Polytechnic University of the Philippines,
12 within a period of one hundred twenty (120) days after the approval of this Act, the
13 PUP Sablayan Campus shall accomplish the following:

14 Submit a five (5) year development plan, including its corresponding program
15 budget, to the CHED, for appropriate recommendation to the DBM;

16 Undergo a management audit in cooperation with the CHED;

17 Accordingly set up its organizational, administrative as well as academic, structure,
18 including the appointment/ designation of University Campus key officials;
19

20 **SECTION 10.** The provisions of Republic Act No. 8292, otherwise known as the
21 "Higher Education Modernization Act of 1997" shall form an integral part of this Act
22 and together shall serve as the governing charter of the University.
23

24 **SECTION 11.** All other powers, functions, privileges, responsibilities and limitations
25 to state universities and/or its official under existing laws shall be deemed granted
26 to or imposed upon the University and/or its officials whenever appropriate.
27

28 **SECTION 12.** All laws, presidential decrees, executive orders, rules and regulations
29 contrary to or inconsistent with the provisions of this Act are hereby repealed,
30 amended or modified accordingly.
31

32 **SECTION 13.** This Act shall take effect upon its approval.
