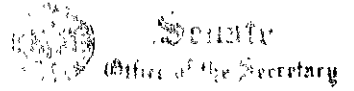


**"Joint Resolution
