





AN ACT CREATING A BARANGAY TO BE KNOWN AS BARANGAY
NAVY IN THE MUNICIPALITY OF CAPAS, PROVINCE OF
TARLAC

*Be it enacted by the Senate and House of Representatives of the Philippines in
Congress assembled:*

1 SECTION 1. *Creation of Barangay Navy.* - The O'Donnel
2 Resettlement Area in Barangay Aranguren, Municipality of Capas, Province of
3 Tarlac which was separated from Barangay Aranguren and constituted as
4 Barangay Cristo Rey under Provincial Ordinance No. 004-2003 in 2003 is
5 hereby created and shall hereafter be known as Barangay Navy.

6 The technical description of Barangay Navy shall be as follows:

7 "Bounded on the East along lines 1-2, by lot 1904, line 2-3 by lot 1903,
8 both in Capas Cadastre; on the South along lines 3-4; 4-5; 5-6; 6-7; 7-8; 8-9;
9 9-10; 10-11; and 11-12 by the Provincial Road to O'Donnel and beyond by the
10 portion of the reservation; and on the West and North along lines 12-13 and 13-
11 14 by the portion of the reservation; and on the East by lot 1706 of Capas
12 Cadastre.

13 Beginning at a point marked "1" on the stretch plan being identical to
14 BBM No. 48 of Capas Cadastre, covering an area of 348.27 hectares, more or
15 less."

1 **SEC. 2. *Conduct and Supervision of Plebiscite.*** – Pursuant to Section
2 10 of Republic Act No. 7160, as amended, otherwise known as the “Local
3 Government Code of 1991”, the new Barangay Navy shall exist upon the
4 majority of the votes cast by the qualified voters in a plebiscite to be
5 conducted and supervised by the Commission on Elections (COMELEC) in
6 the area affected within sixty (60) days from the effectivity of this Act.

7 The expenses for such plebiscite shall be borne by the Municipality of
8 Capas, Province of Tarlac.

9 **SEC. 3. *Incumbent Barangay Officials.*** – The incumbent barangay
10 officials of Barangay Cristo Rey shall continue to hold office until such time
11 that their successors have been duly elected and qualified.

12 **SEC. 4. *Public Infrastructures and Facilities.*** – All existing public
13 infrastructures and facilities for public use existing therein at the time of the
14 approval of this Act are hereby transferred without cost or compensation to
15 and shall be administered by the new barangay.

16 **SEC. 5. *Internal Revenue Allotment Shares.*** – Barangay Navy shall
17 be entitled to Internal Revenue Allotment (IRA) shares pursuant to Section
18 285 of Republic Act No. 7160, as amended, otherwise known as the “Local
19 Government Code of 1991”.

20 **SEC. 6. *Separability Clause.*** – If, for any reason, any part or provision
21 of this Act is declared unconstitutional or invalid, the other parts or provisions
22 which are not affected thereby shall continue to be in full force and effect.

23 **SEC. 7. *Effectivity.*** – This Act shall take effect fifteen (15) days after
24 its publication in any newspaper of general circulation.
