

AN ACT ESTABLISHING THE ORANI LAND TRANSPORTATION EXTENSION OFFICE IN THE MUNICIPALITY OF ORANI, PROVINCE OF BATAAN AND APPROPRIATING FUNDS THEREFOR

EXPLANATORY NOTE


This bill seeks to establish the Orani Land Transportation Extension Office in the Municipality of Orani, Province of Bataan.

The Land Transportation Office (LTO) is a vital government agency tasked with the promotion of safety and public service in land transportation throughout the country. The LTO provides a rationalized system of motor vehicle registration, license issuance, law enforcement and adjudication of traffic violation cases. LTO regional offices, district offices and licensing centers nationwide complement the central office in the delivery of its services. At present, LTO Licensing Center in the Province of Bataan is located in the Municipality of Pilar, Bataan, which is in the Second District of Bataan. People from various municipalities of Bataan need to travel to Pilar, Bataan to avail of the services of the LTO. Hence, establishing an LTO Extension Office in the Municipality of Orani will be beneficial not only to its residents but to those from nearby municipalities, especially those coming from the First Legislative District of Bataan. An LTO Extension Office in Orani means that the effort, money and time spent to transact business with the LTO will be greatly minimized.

In line with the policy of the State to provide access to services and give preferential attention to the welfare of the general populace, the approval of this bill is earnestly recommended.

AN ACT
ESTABLISHING THE ORANI LAND TRANSPORTATION EXTENSION OFFICE IN
THE MUNICIPALITY OF ORANI, PROVINCE OF BATAAN AND APPROPRIATING
FUNDS THEREFOR

Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:

SECTION 1. There shall be established, under the Department of Transportation and Communications, the Orani Land Transportation Extension Office in the Municipality of Orani, Province of Bataan.

SEC. 2. The amount necessary for the implementation of this Act shall be charged to the current appropriations for the Department of Transportation and Communications. Thereafter, such sum as may be necessary for its operation and maintenance shall be included in the annual General Appropriations Act.

SEC. 3. This Act shall take effect fifteen (15) days after publication in the Official Gazette or a newspaper of general circulation.
