MR. PRESIDENT:

The Committee on Games, Amusement and Sports and the Committee on Finance, to which was referred House Bill No. 4308, introduced by Representative Del Rosario A.G., entitled:

**“AN
ACT ESTABLISHING THE DAVAO SPORTS ACADEMY IN THE CITY OF TAGUM, PROVINCE OF DAVAO DEL NORTE TO BE LOCATED IN THE DAVAO DEL NORTE SPORTS AND CULTURAL CENTER AND ALLOCATING FUNDS THEREFOR”**

have considered the same and have the honor to report it back to the Senate with the recommendation that the bill be approved with the following amendments:

1. On page 1, Section 1, line 2, delete the words “Cultural Center” and replace with the words “Tourism Complex”.
2. On the same page and Section, lines 2-3, insert the words “Del Norte Regional” between the words “Davao” and “Sports”
3. On page 2, between lines 7 and 8, insert a new Section as “Sec. 4.” with subtitle “Appropriations.-” to read as follows:, and the number of the succeeding section renumbered accordingly.


THE SECRETARY OF EDUCATION SHALL IMMEDIATELY INCLUDE IN THE DEPARTMENT’S PROGRAMS THE OPERATION OF THE DAVAO SPORTS ACADEMY, THE FUNDING OF WHICH SHALL BE INCLUDED IN THE ANNUAL GENERAL APPROPRIATIONS ACT

4. On the same page 2, line 8, renumber sec. 4 to "Sec. 5."
5. The Title shall read as follows:

**"AN ACT
ESTABLISHING THE DAVAO DEL NORTE REGIONAL SPORTS
ACADEMY TO BE LOCATED IN THE DAVAO DEL NORTE SPORTS
AND TOURISM COMPLEX AND ALLOCATING FUNDS THEREFOR"**

BY REPRESENTATIVE DEL ROSARIO (A. G.), PER COMMITTEE REPORT NO. 181

AN ACT ESTABLISHING THE DAVAO SPORTS ACADEMY IN THE CITY OF TAGUM, PROVINCE OF DAVAO DEL NORTE TO BE LOCATED IN THE DAVAO DEL NORTE SPORTS AND CULTURAL CENTER AND ALLOCATING FUNDS THEREFOR

Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:

1 SECTION 1. There shall be established in the Davao del Norte Sports
2 and Cultural Center in Tagum City, Province of Davao del Norte, the Davao
3 Sports Academy, which shall be constituted as the primary sports development
4 and training center for the Davao Region.

5 SEC. 2. The Provincial Government of Davao del Norte, in
6 coordination with the Philippine Sports Commission (PSC), shall take the
7 necessary steps to upgrade, improve and modernize existing facilities,
8 equipment and personnel, and integrate them into the newly created sports
9 academy and training center.

10 The Provincial Government of Davao del Norte, in coordination with
11 the PSC, shall create the necessary training programs and competitions, as

1 well as the system by which the facilities shall be maintained and managed in
2 order to accomplish the objectives and purposes of this Act.

3 SEC. 3. The construction, establishment and operation of the Davao
4 Sports Academy shall be funded by the Provincial Government of Davao del
5 Norte and such funds as may be granted by the PSC and by the Office of the
6 President. In addition, grants and endowments may be obtained from local or
7 foreign sources intended for sports development.

8 SEC. 4. This Act shall take effect fifteen (15) days after its publication
9 in the *Official Gazette* or in a newspaper of general circulation.
