





AN ACT ESTABLISHING A NATIONAL HIGH SCHOOL IN BARANGAY  
STO. NIÑO, PARAÑAQUE CITY TO BE KNOWN AS STO. NIÑO  
NATIONAL HIGH SCHOOL AND APPROPRIATING FUNDS  
THEREFOR

*Be it enacted by the Senate and House of Representatives of the Philippines in  
Congress assembled:*

1           SECTION 1. There is hereby established, under the supervision of the  
2 Department of Education, a national high school in Barangay Sto. Niño,  
3 Parañaque City to be known as Sto. Niño National High School.

4           SEC. 2. The Secretary of Education shall immediately include in the  
5 Department's program the operationalization of the Sto. Niño National High  
6 School, the funding of which shall be included in the annual General  
7 Appropriations Act.

8           SEC. 3. The Secretary of Education shall issue rules and regulations  
9 necessary to carry out the purpose of this Act.

10          SEC. 4. This Act shall take effect fifteen (15) days after its publication  
11 in the *Official Gazette* or in a newspaper of general circulation.

1 School, the initial funding of which shall be charged against the current year's  
2 appropriation of the Parafiaque National High School – Don Galo Annex.  
3 Thereafter, the amount necessary for the continued operation of the school  
4 shall be included in the annual General Appropriations Act.

5 SEC. 4. The Secretary of Education shall issue rules and regulations  
6 necessary to carry out the purpose of this Act.

7 SEC. 5. This Act shall take effect fifteen (15) days after its publication  
8 in the *Official Gazette* or in a newspaper of general circulation.
