QUEZON, METRO MANILA TO CORAZON C. AQUINO
NATIONAL HIGH SCHOOL

*Be it enacted by the Senate and House of Representatives of the Philippines in
Congress assembled:*

1 SECTION 1. *Renaming of a National High School.* – The name of
2 Batasan Hills National High School in Barangay Batasan Hills, City of
3 Quezon, Metro Manila is hereby changed to Corazon C. Aquino National High
4 School.

5 SEC. 2. *Location of the Main Campus.* – The main campus of the
6 Corazon C. Aquino National High School shall continue to remain in its
7 present location in Barangay Batasan Hills, City of Quezon, Metro Manila.

8 SEC. 3. *Effectivity.* – This Act shall take effect fifteen (15) days after
9 its official publication in the *Official Gazette*.
