MR. PRESIDENT:

The Committee on Games, Amusement and Sports and the Committee on Finance, to which was referred House Bill No. 4605, introduced by Representative Tolentino entitled:

**“AN
ACT ESTABLISHING THE ALFONSO SPORTS ACADEMY AND
TRAINING CENTER IN THE MUNICIPALITY OF ALFONSO, SEVENTH
CONGRESSIONAL DISTRICT, PROVINCE OF CAVITE AND
APPROPRIATING FUNDS THEREFOR”**

have considered the same and have the honor to report it back to the Senate with the recommendation that the bill be approved with the following amendments:

1. On page 1, line 7, Sec.2., insert the words “PROVINCE OF CAVITE WITH THE” between the words “The” and “Municipality”.
2. On page 2, line 1, insert the words “PROVINCE OF CAVITE WITH THE” between the words “The” and “Municipality”.
3. On page 2, line 7, Sec.3., insert the phrase “AND BY OTHER FUNDS THAT MAY BE ALLOCATED BY THE PROVINCE OF CAVITE,” between the words “Alfonso,” and “and”.
4. On page 2, between lines 9 and 10, insert a new Section as “Sec.4.” with subtitle “Appropriations.-” to read as follows:, and the number of the succeeding section renumbered accordingly.

“THE SECRETARY OF EDUCATION SHALL IMMEDIATELY INCLUDE IN THE DEPARTMENT’S PROGRAMS THE OPERATION OF THE ALFONSO SPORTS ACADEMY AND TRAINING CENTER, THE FUNDING OF WHICH SHALL BE INCLUDED IN THE ANNUAL GENERAL APPROPRIATIONS ACT.”


5. On the same page 2, add a new Section as “Sec. 5.” on implementing rules and regulations (IRR) to read as follows:

“THE PSC, IN COORDINATION WITH THE DEPARTMENT OF EDUCATION (DepEd), THE PROVINCIAL GOVERNMENT OF CAVITE AND THE MUNICIPALITY OF ALFONSO, SHALL PROMULGATE THE NECESSARY RULES AND REGULATIONS FOR THE IMPLEMENTATION OF THIS ACT WITHIN 90 DAYS AFTER ITS ENACTMENT INTO LAW.”

6. On the same page 2, line 10, renumber Sec. 4 to “Sec.6.”

AN ACT ESTABLISHING THE ALFONSO SPORTS ACADEMY AND TRAINING CENTER IN THE MUNICIPALITY OF ALFONSO, SEVENTH CONGRESSIONAL DISTRICT, PROVINCE OF CAVITE AND APPROPRIATING FUNDS THEREFOR

Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:

1 SECTION 1. There shall be established in the Municipality of Alfonso,
2 Seventh Congressional District, Province of Cavite, a sports academy and
3 training center that shall be known as the Alfonso Sports Academy and
4 Training Center, and which shall be the primary sports development and
5 training center for the Seventh Congressional District of the Province of
6 Cavite and other neighboring towns and provinces.

7 SEC. 2. The Municipality of Alfonso, in coordination with the
8 Philippine Sports Commission (PSC), shall take the necessary steps to
9 upgrade, improve and modernize existing facilities, equipment, and personnel
10 and integrate them into the newly created sports academy and training center.

1 The Municipality of Alfonso, in coordination with the PSC, shall create
2 the necessary training programs, appropriate tournaments and competitions, as
3 well as the system by which the facilities shall be maintained and managed in
4 order to accomplish the objectives of this Act.

5 SEC. 3. The construction, establishment and operation of the Alfonso
6 Sports Academy and Training Center shall be funded by the Municipality of
7 Alfonso, and such funds as may be granted by the PSC and by the Office of
8 the President. In addition, grants and endowments may be obtained from local
9 or foreign sources intended for sports development.

10 SEC. 4. This Act shall take effect fifteen (15) days after its publication
11 in the *Official Gazette* or in a newspaper of general circulation.
