Recommending its approval with amendments.

MR. PRESIDENT:

The Committee on Games, Amusement and Sports and the Committee on Finance, to which was referred House Bill No. 4461, introduced by Representative Gullas entitled:

**"AN
ACT ESTABLISHING THE TALISAY SPORTS ACADEMY AND
TRAINING CENTER IN THE CITY OF TALISAY, PROVINCE OF CEBU
AND APPROPRIATING FUNDS THEREFOR"**

have considered the same and have the honor to report it back to the Senate with the recommendation that the bill be approved with the following amendments:

1. On page 1, line 5, Sec.2., insert the words "PROVINCE OF CEBU WITH THE" between the words "The" and "City".
2. On the same page, line 9, ., insert the words "PROVINCE OF CEBU WITH THE" between the words "The" and "City".
3. On page 2, between lines 6 and 7, insert a new Section as "Sec.4." with subtitle "Appropriations.-" to read as follows:, and the number of the succeeding section renumbered accordingly.

"THE SECRETARY OF EDUCATION SHALL IMMEDIATELY INCLUDE IN THE DEPARTMENT'S PROGRAMS THE OPERATION OF THE TALISAY SPORTS ACADEMY AND TRAINING CENTER, THE FUNDING OF WHICH SHALL BE INCLUDED IN THE ANNUAL GENERAL APPROPRIATIONS ACT."

4. On the same page 2, add a new Section as "Sec. 5." on implementing rules and regulations (IRR) to read as follows:

"THE PSC, IN COORDINATION WITH THE DEPARTMENT OF EDUCATION (DepEd), THE PROVINCIAL GOVERNMENT OF CEBU AND THE CITY GOVERNMENT OF TALISAY, SHALL PROMULGATE THE NECESSARY

RULES AND REGULATIONS FOR THE IMPLEMENTATION OF THIS ACT
WITHIN 90 DAYS AFTER ITS ENACTMENT INTO LAW.”

5. On the same page 2, line 7, renumber Sec. 4 to “Sec.6.”

**AN ACT ESTABLISHING THE TALISAY SPORTS ACADEMY AND
TRAINING CENTER IN THE CITY OF TALISAY, PROVINCE OF
CEBU AND APPROPRIATING FUNDS THEREFOR**

*Be it enacted by the Senate and House of Representatives of the Philippines in
Congress assembled:*

1 SECTION 1. There shall be established in the City of Talisay, a sports
2 academy to be known as the Talisay Sports Academy and Training Center,
3 which shall be constituted as the primary sports development and training
4 center for the whole Province of Cebu and the neighboring towns thereat.

5 SEC. 2. The City Government of Talisay, in coordination with the
6 Philippine Sports Commission (PSC), shall take the necessary steps to upgrade
7 and modernize existing facilities, equipment and personnel and integrate them
8 into the newly created sports academy.

9 The City Government of Talisay, in coordination with the PSC, shall
10 create the necessary training programs and competitions, as well as the system
11 by which the facilities shall be maintained and managed in order to accomplish
12 the objectives and purposes of this Act.

1 SEC. 3. The construction, establishment and operation of the Talisay
2 Sports Academy and Training Center shall be funded by the government of the
3 City of Talisay, and by other funds that may be allocated by the Province of
4 Cebu, and such funds as may be granted by the PSC and by the Office of the
5 President. In addition, grants and endowments may be obtained from local or
6 foreign sources intended for sports development.

7 SEC. 4. This Act shall take effect fifteen (15) days after its publication
8 in the *Official Gazette* or in a newspaper of general circulation.
