


have considered the same and have the honor to report it back to the Senate with

AN ACT CREATING AN ADDITIONAL LEGISLATIVE DISTRICT IN THE PROVINCE OF CEBU TO BE KNOWN AS THE SEVENTH LEGISLATIVE DISTRICT

*Be it enacted by the Senate and House of Representatives of the Philippines in
Congress assembled:*

1 SECTION 1. *Creation of the Seventh Legislative District.* – There is
2 hereby created an additional legislative district in the Province of Cebu to be
3 known as the Seventh Legislative District by reapportioning the current Second
4 Legislative District to commence in the next national and local elections after
5 the effectivity of this Act. Henceforth, the following municipalities shall
6 comprise the Seventh Legislative District, to wit:

- 7 (a) Dumanjug;
8 (b) Ronda;
9 (c) Alcantara;
10 (d) Moalboal;
11 (e) Badian;
12 (f) Alegria;

- 1 (g) Malabuyoc; and
- 2 (h) Ginatilan.

3 The current Second Legislative District of the Province of Cebu, which
4 shall continue to be designated as such, shall be composed of the following
5 municipalities, to wit:

- 6 (a) Argao;
- 7 (b) Dalaguete;
- 8 (c) Alcoy;
- 9 (d) Bolijoon; *Bolijon*
- 10 (e) Oslob;
- 11 (f) Santander; and
- 12 (g) Samboan.

13 SEC. 2. *Rules and Regulations.* – The Commission on Elections shall
14 issue the necessary rules and regulations within thirty (30) days upon approval
15 of this Act.

16 SEC. 3. *Repealing Clause.* – All laws, rules and regulations which are
17 inconsistent with this Act are hereby repealed, amended or modified
18 accordingly.

19 SEC. 4. *Effectivity.* – This Act shall take effect fifteen (15) days after
20 its publication in any newspaper of general circulation.
