BARBARA AND CABATUAN, AND ILOILO CITY, AS "SENATOR BENIGNO S. AQUINO, JR. AVENUE"

Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:

1 SECTION 1. A stretch of the national highway along the Iloilo

2 Diversion Road/Iloilo Capiz Road (old route) which begins at the Junction of

3 General Luna to the Airport Access Road and ends at the Gate of the Iloilo

4 International Airport, traversing the municipalities of Pavia, Sta. Barbara and

Cabatuan, and Iloilo City, with a total length of 16.6153 kilometers, shall

hereinaster be known as the "Senator Benigno S. Aquino, Jr. Avenue".

7 SEC. 2. The Department of Public Works and Highways shall issue the

8 necessary rules, orders and circulars to implement the provision of this Act.

9 SEC. 3. This Act shall take effect fifteen (15) days after its publication

in a newspaper of general circulation.
