





ABANGAY TO BARANGAY POBLACION, MUNICIPALITY
OF DINGLE, PROVINCE OF ILOILO AS BOARD MEMBER
RUFINO A. PALABRICA JR. NATIONAL ROAD

*Be it enacted by the Senate and House of Representatives of the Philippines in
Congress assembled:*

1 SECTION 1. The national road that stretches from Barangay Abangay
2 to Barangay Poblacion in the Municipality of Dingle, Province of Iloilo is
3 hereby named as Board Member Rufino A. Palabrica Jr. National Road.

4 SEC. 2. The Department of Public Works and Highways shall issue the
5 necessary rules, orders and circulars to implement the provision of this Act.

6 SEC. 3. This Act shall take effect fifteen (15) days after its publication
7 in a newspaper of general circulation.
