AN ACT RENAMING THE GUREL – BOKOD – KABAYAN – ABATAN  
ROAD IN THE PROVINCE OF BENGUET TO CONG. ANDRES  
ACOP COSALAN ROAD

*Be it enacted by the Senate and House of Representatives of the Philippines in  
Congress assembled:*

1           SECTION 1. In recognition of his public service rendered to the people  
2 of the Province of Benguet from the Sixth to the Seventh Congress and the  
3 Interim Batasang Pambansa, the Gurel – Bokod – Kabayan – Abatan Road is  
4 renamed as the Cong. Andres Acop Cosalan Road.

5           SEC. 2. The Department of Public Works and Highways shall place  
6 appropriate markers along the Cong. Andres Acop Cosalan Road and issue the  
7 necessary orders and circulars to implement the provision of this Act.

8           SEC. 3. This Act shall take effect immediately upon its approval.
