AN ACT NAMING AS "ST. PAUL AVENUE" THE ROAD BESIDE THE ST. PAUL COLLEGE OF ILOCOS SUR (SPCIS) HIGH SCHOOL DEPARTMENT LOCATED IN THE MUNICIPALITY OF BANTAY, PROVINCE OF ILOCOS SUR AND THE SPCIS COLLEGE DEPARTMENT LOCATED IN BARANGAY BAYUBAY, MUNICIPALITY OF SAN VICENTE, PROVINCE OF ILOCOS SUR

Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:

1 SECTION 1. The southern part of the road beside the St. Paul College
2 of Ilocos Sur (SPCIS) High School Department and the SPCIS Elementary
3 Department in the Municipality of Bantay, Province of Ilocos Sur and the road
4 fronting the SPCIS College Department in Barangay Bayubay, Municipality of
5 San Vicente, Province of Ilocos Sur is hereby named St. Paul Avenue.

6 SEC. 2. The Department of Public Works and Highways shall issue the
7 necessary rules, orders and circulars to implement the provision of this Act.

8 SEC. 3. This Act shall take effect fifteen (15) days after its publication
9 in the *Official Gazette* or in a newspaper of general circulation.
