G. BAUTISTA ELEMENTARY SCHOOL

*Be it enacted by the Senate and House of Representatives of the Philippines in
Congress assembled:*

1 SECTION 1. *Renaming of an Elementrary School.* – The name of
2 Saverona Elementary School in Barangay Saverona, Municipality of Talugtug,
3 Province of Nueva Ecija is hereby changed to Alberto G. Bautista Elementary
4 School.

5 SEC. 2. *Location of the Main Campus.* – The main campus of Alberto
6 G. Bautista Elementary School shall continue to remain in its present location
7 in Barangay Saverona, Municipality of Talugtug, Province of Nueva Ecija.

8 SEC. 3. *Effectivity.* – This Act shall take effect fifteen (15) days after
9 its publication in the *Official Gazette*.
