AN ACT SEPARATING THE SAN JOSE NATIONAL HIGH SCHOOL – DANIEL C. MANTOS ANNEX IN BARANGAY DANIEL C. MANTOS, MUNICIPALITY OF MAHAYAG, PROVINCE OF ZAMBOANGA DEL SUR FROM THE SAN JOSE NATIONAL HIGH SCHOOL, CONVERTING IT INTO AN INDEPENDENT NATIONAL HIGH SCHOOL TO BE KNOWN AS DANIEL C. MANTOS NATIONAL HIGH SCHOOL AND APPROPRIATING FUNDS THEREFOR

*Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:*

1           SECTION 1. The San Jose National High School – Daniel C. Mantos  
2 Annex in Barangay Daniel C. Mantos, Municipality of Mahayag, Province of  
3 Zamboanga del Sur is hereby separated from the San Jose National High  
4 School and converted into an independent national high school to be known as  
5 Daniel C. Mantos National High School.

6           SEC. 2. All personnel, assets, liabilities and records of the San Jose  
7 National High School – Daniel C. Mantos Annex are hereby transferred to and  
8 absorbed by the Daniel C. Mantos National High School.

1           SEC. 3. The Secretary of Education shall immediately include in the  
2 Department's program the operationalization of the Daniel C. Mantos National  
3 High School, the initial funding of which shall be charged against the current  
4 year's appropriation of the San Jose National High School – Daniel C.  
5 Mantos Annex. Thereafter, the amount necessary for the continued operation  
6 of the school shall be included in the annual General Appropriations Act.

7           SEC. 4. The Secretary of Education shall issue the rules and regulations  
8 necessary to carry out the purpose of this Act.

9           SEC. 5. This Act shall take effect fifteen (15) days after its publication  
10 in the *Official Gazette* or in a newspaper of general circulation.

Approved.
