AN ACT SEPARATING THE SILAE NATIONAL HIGH SCHOOL – ST. PETER ANNEX IN BARANGAY ST. PETER, CITY OF MALAYBALAY, PROVINCE OF BUKIDNON FROM THE SILAE NATIONAL HIGH SCHOOL, CONVERTING IT INTO AN INDEPENDENT NATIONAL HIGH SCHOOL TO BE KNOWN AS ST. PETER NATIONAL HIGH SCHOOL AND APPROPRIATING FUNDS THEREFOR

*Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:*

1           SECTION 1. The Silae National High School – St. Peter Annex in  
2   Barangay St. Peter, City of Malaybalay, Province of Bukidnon is hereby  
3   separated from the Silae National High School and converted into an  
4   independent national high school to be known as St. Peter National High  
5   School.

6           SEC. 2. All personnel, assets, liabilities and records of the Silae  
7   National High School – St. Peter Annex are hereby transferred to and absorbed  
8   by the St. Peter National High School.

9           SEC. 3. The Secretary of Education shall immediately include in the  
10   Department's program the operationalization of the St. Peter National High

1 School, the initial funding of which shall be charged against the current year's  
2 appropriation of the Silae National High School – St. Peter Annex. Thereafter,  
3 the amount necessary for the continued operation of the school shall be  
4 included in the annual General Appropriations Act.

5 SEC. 4. The Secretary of Education shall issue such rules and  
6 regulations as may be necessary to carry out the purpose of this Act.

7 SEC. 5. This Act shall take effect fifteen (15) days after its publication  
8 in the *Official Gazette* or in a newspaper of general circulation.
