MANDATING THE INTEGRATION OF PROFESSIONS BY CREATING AN ACCREDITED INTEGRATED PROFESSIONAL ORGANIZATIONS (AIPOS) FOR EVERY PROFESSION, APPROPRIATING FUNDS THEREFOR, AND FOR OTHER PURPOSES

EXPLANATORY NOTE

While the duty to regulate the practice of each profession is vested by law in the various Professional Regulatory Boards (Boards) created to govern the different professions, the complementary role of the professional organizations in this respect cannot be overemphasized. Hence, our regulatory laws for the various professions define not only the mandate and functions of the Boards but also those of the professional organizations to be accredited by the Professional Regulation Commission (Commission) upon the recommendation by the Boards.

Included among these functions is their duty to submit nominations to vacancies in the Boards pursuant to pertinent laws and regulations. Likewise, national policies directly affecting the practice of professions, including the Code of Ethics and Code of Technical Standards for the Profession are developed and promulgated in close consultation and coordination with the accredited professional organizations (APOs).

The Boards also conduct inspection and monitoring of firms, establishments and higher educational institutions with the assistance of the APOs. The latter also take part in the implementation of the Continuing Professional Development (CPD) programs for each profession as members of the CPD Councils. Even in technical discussions and in consultations on bills relating to the practice of profession, the APOs are normally invited to send representatives as resource persons.

The PRC began to accredit professional organizations in the different professions in 1975. One of the first professional regulatory laws which mandate the integration of the profession was Republic Act No. 7836, also known as the Philippine Teachers Professionalization Act of 1994, as amended. There are at present seventeen (17) professions whose laws provide for the integration of the profession.

This measure will institutionalize and streamline the concept of integration across all professions with the creation of an Accredited and Integrated Professional Organization (AIPO) for each of the regulated professions that will be national in scope. Membership in the AIPO for each profession shall be also compulsory.

The proposed set-up will also provide a stable platform for the expeditious discussion and resolution of all issues and concerns relating to the practice of each profession, as well as allow easier collaboration and cooperation between the Commission, the Board and the professionals they are supposed to regulate.

For the foregoing reasons, the expeditious approval of this bill is earnestly requested.

AN ACT

MANDATING THE INTEGRATION OF PROFESSIONS BY CREATING AN ACCREDITED INTEGRATED PROFESSIONAL ORGANIZATIONS (AIPOS) FOR EVERY PROFESSION, APPROPRIATING FUNDS THEREFOR, AND FOR OTHER PURPOSES

Be it enacted by the Senate and the House of Representatives of the Republic of the Philippines in Congress assembled:

ARTICLE I GENERAL PROVISIONS

Section 1. *Short Title.* – This Act shall be known as the *"Integration of the Professions Act of 2015".*

8 Section 2. Statement of Policy. – The State, thru the Professional Regulation 9 Commission (Commission) and the Professional Regulatory Boards (Boards) for each 10 profession, recognizes the vital role of professionals in nation-building by promoting the 11 sustained development of a reservoir of quality and competent professionals through the 12 administration of the licensure examinations and the provision of the highest standards of 13 professional practice.

In pursuance thereof, the different professional organizations shall be tapped to provide assistance and support to the Commission and the Boards; and to further strengthen and empower these professional organizations, their integration into a single, accredited national organization for each profession shall be considered a priority thrust of the government.

Section 3. Objectives. – This Act provides for the:

- (a) Institutionalization of the concept of integration of professionals in each professions
 into an Accredited Integrated Professional Organization (AIPO) for said profession
 across all professions;
- 27 (b) Mandate and functions of the AIPO;
- (c) Criteria and procedure in the creation of the Accredited Integrated Professional
 Organization (AIPO) in each profession; and
- 30 (d) Regulation and supervision of the operations of the AIPOs.

4	(a) Accreditation refers to the power of the Commission to certify or recognize an entity

6.2 Composition of the Board of Trustees. This new organization shall be incorporated or registered as a non-stock and non-profit organization to be governed by a Board of Trustees. The initial Board of Trustees shall be composed of representatives from the existing professional organizations on the basis of the number of their total membership.

- There shall be a minimum of five (5) to a maximum of fifteen (15) members of the Board of Trustees that will be chosen depending on the number of professional organizations existing at the time of integration. 9 10
- The members of the subsequent Board of Trustees shall be elected annually or as 11 often as provided by the constitution and by-laws in the manner provided therein. 12
- 6.3 Articles of Incorporation and By-laws. The Commission shall come up with a 14 standard Articles of Incorporation and By-laws that will govern the operations of all 15 AIPOs. The Articles of Incorporation and By-laws, as adopted by each profession, 16 shall, upon approval by the Commission, be submitted to the Securities and 17 Exchange Commission (SEC) for registration. 18 19
- The Articles of Incorporation and By-laws referred to above shall be adopted by all 20 the other AIPOs that will be subsequently created after the approval of this Act. 21 22
 - 6.4 Accreditation by the Commission. The umbrella organization shall apply for accreditation with the Commission. Should the applicant meet the conditions to be certified and recognized as the AIPO for a given profession, the corresponding Certificate of Accreditation shall then be issued by the Commission.
 - The accreditation to be granted by the Commission shall be permanent in nature.
- 31 Section 7. Supervisory Powers of the Commission over the AIPOs. - The Commission shall exercise supervisory powers over the operation of the AIPOs and, thus, 32 may call upon its Board of Trustees and/or other officers who, under this Act, shall be 33 34 accountable for all the activities and programs undertaken by the AIPO.
- Section 8. Implementing Rules and Regulations. Within ninety (90) days from 37 the effectivity of this Act, the Commission, in consultation with the Boards for the different 38 professions and all relevant professional organizations, shall issue the rules and 39 regulations to implement the provisions thereof. 40
- Section 9. Appropriations. The funding necessary to enforce the provisions of 43 44 this Act shall be included in the annual budget of the Commission pursuant to the General 45 Appropriations Act.
- Section 10. Separability Clause. If any section or provision of this Act or any part 48 hereof be declared unconstitutional or invalid, the same shall not affect the remaining 49 sections and/or provisions otherwise considered as valid and legal. 50
- 53 Section 11. Repealing Clause. - All laws, presidential decrees, executive orders, resolutions, and other administrative issuances or part/s thereof which are inconsistent or 54 in conflict with this Act are hereby repealed, amended and/or modified accordingly. 55

Section 12. Effectivity. - This Act shall take effect fifteen (15) days after its
 complete publication in the Official Gazette or in two (2) newspapers of general circulation
 in the Philippines.
