

Re: House Bill No. 103

Recommending its approval with amendments.

Sponsor: Senator Marcos, Jr.

MR. PRESIDENT:

The Committee on Local Government to which was referred House Bill No. 103, introduced by Representatives Mercado-Revilla and Primicias-Agabas, entitled:

"AN ACT

DECLARING JUNE 23 OF EVERY YEAR A SPECIAL NONWORKING HOLIDAY IN THE CITY OF BACOOR TO COMMEMORATE ITS ANNIVERSARY AS A CITY"

has considered the same and has the honor to report it back to the Senate with the recommendation that it be approved with the following amendments:

 On page 1, line 2, delete the word "nonworking" and in lieu thereof insert the word "WORKING";

- On the same page and line, after the word "holiday" insert the phrase "AND NO CLASS DAY IN SCHOOLS";
- 3. On the same page, line 3, after the word "City" insert a new section to read as follows:

"SECTION 2. FOR WORK PERFORMED ON A SPECIAL WORKING HOLIDAY, AN EMPLOYEE IS ENTITLED TO HIS/HER REGULAR WAGE."

and renumber the succeeding sections accordingly;

4. The title of the bill should now read as follows:

"AN ACT DECLARING JUNE 23 OF EVERY YEAR AS A SPECIAL WORKING HOLIDAY AND NO CLASS DAY IN SCHOOLS IN THE CITY OF BACOOR TO COMMEMORATE ITS ANNIVERSARY AS A CITY"

AN ACT DECLARING JUNE 23 OF EVERY YEAR AS A SPECIAL
NONWORKING HOLIDAY IN THE CITY OF BACOOR TO COMMEMORATE ITS ANNIVERSARY AS A CITY
Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:
SECTION 1. June 23 of every year is hereby declared as a special
nonworking holiday in the City of Bacoor to commemorate its anniversary as a
City.
SEC. 2. This Act shall take effect fifteen (15) days after its publication
in the Official Gazette or in two (2) newspapers of general circulation.
Approved,
