MR. PRESIDENT:

The Committee on Local Government to which was referred House Bill No. 3945, introduced by Representatives Adiong, Oaminal, Hernandez, Bello S., Gutierrez, Santiago and Primicias-Agabas, entitled:

**"AN ACT
DECLARING JULY 4 OF EVERY YEAR A SPECIAL NONWORKING HOLIDAY
IN THE PROVINCE OF LANA DEL SUR IN COMMEMORATION OF ITS
FOUNDATION DAY"**

has considered the same and has the honor to report it back to the Senate with the recommendation that it be approved with the following amendments:

1. On page 1, line 2, delete the word "nonworking" and in lieu thereof insert the word "**WORKING**";

2. On the same page and line, after the word "holiday" insert the phrase **"AND NO CLASS DAY IN SCHOOLS"**;

3. On the same page, line 3, after the word "day" insert a new section to read as follows:

"SECTION 2. FOR WORK PERFORMED ON A SPECIAL WORKING HOLIDAY, AN EMPLOYEE IS ENTITLED TO HIS/HER REGULAR WAGE."

and renumber the succeeding sections accordingly;

4. The title of the bill should now read as follows:

"AN ACT DECLARING JULY 4 OF EVERY YEAR A SPECIAL WORKING HOLIDAY AND NO SCHOOL DAY IN SCHOOLS IN THE PROVINCE OF LANA DEL SUR IN COMMEMORATION OF ITS FOUNDATION DAY"





AN ACT DECLARING JULY 4 OF EVERY YEAR A SPECIAL
NONWORKING HOLIDAY IN THE PROVINCE OF LANA O DEL
SUR IN COMMEMORATION OF ITS FOUNDATION DAY

*Be it enacted by the Senate and House of Representatives of the Philippines in
Congress assembled:*

1 SECTION 1. July 4 of every year is hereby declared a special
2 nonworking holiday in the Province of Lanao del Sur in commemoration of its
3 foundation day.

4 SEC. 2. This Act shall take effect fifteen (15) days after its publication
5 in the *Official Gazette* or in a newspaper of general circulation.
