### MR, PRESIDENT:

The Committee on Local Government to which was referred House Bill No. 3962, introduced by Representatives Teodoro and Primicias-Agabas, entitled:

 On page 1, line 2, delete the word "nonworking" and in lieu thereof insert the word "WORKING";

- 3. On the same page, line 3, after the word "Day" insert a new section to read as follows:

"SECTION 2. FOR WORK PERFORMED ON A SPECIAL WORKING HOLIDAY, AN EMPLOYEE IS ENTITLED TO HIS/HER REGULAR WAGE."

and renumber the succeeding sections accordingly;

4. The title of the bill should now read as follows:

AN ACT DECLARING APRIL 16 OF EVERY YEAR A SPECIAL NONWORKING HOLIDAY IN THE CITY OF MARIKINA IN COMMEMORATION OF ITS FOUNDING ANNIVERSARY TO BE KNOWN AS "MARIKINA CITY DAY"

Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:

- SECTION 1. April 16 of every year is hereby declared a special nonworking holiday in the City of Marikina in commemoration of its founding anniversary to be known as "Marikina City Day".
- SEC. 2. This Act shall take effect fifteen (15) days after its publication in the Official Gazette or in a newspaper of general circulation.
