

Recommending its approval with amendments.

MR. PRESIDENT:

The Committee on Local Government to which was referred House Bill No. 3968, introduced by Representatives Tolentino and Primicias-Agabas, entitled:

"AN ACT

DECLARING JUNE 21 OF EVERY YEAR A SPECIAL NONWORKING HOLIDAY IN TAGAYTAY CITY, PROVINCE OF CAVITE IN COMMEMORATION OF ITS FOUNDATION DAY TO BE KNOWN AS "CHARTER DAY OF TAGAYTAY CITY" OR "ARAW NG LUNGSOD NG TAGAYTAY"

has considered the same and has the honor to report it back to the Senate with the recommendation that it be approved with the following amendments:

1. On page 1, line 2, delete the word "nonworking" and in lieu thereof insert the word "**WORKING**";

2. On the same page and line, after the word "holiday" insert the phrase **"AND NO CLASS DAY IN SCHOOLS"**;

3. On the same page, line 4, after the word "Tagaytay" insert a new section to read as follows:

"SECTION 2. FOR WORK PERFORMED ON A SPECIAL WORKING HOLIDAY, AN EMPLOYEE IS ENTITLED TO HIS/HER REGULAR WAGE."

and renumber the succeeding sections accordingly;

4. The title of the bill should now read as follows:

"AN ACT DECLARING JUNE 21 OF EVERY YEAR A SPECIAL WORKING HOLIDAY AND NO CLASS DAY IN SCHOOLS IN TAGAYTAY CITY, PROVINCE OF CAVITE IN COMMEMORATION OF ITS FOUNDING DAY TO BE KNOWN AS "CHARTER DAY OF TAGAYTAY CITY" OR "ARAW NG LUNGSOD NG TAGAYTAY"

AN ACT DECLARING JUNE 21 OF EVERY YEAR A SPECIAL
NONWORKING HOLIDAY IN TAGAYTAY CITY, PROVINCE OF
CAVITE IN COMMEMORATION OF ITS FOUNDATION DAY TO
BE KNOWN AS "CHARTER DAY OF TAGAYTAY CITY" OR
"ARAW NG LUNGSOD NG TAGAYTAY"

*Be it enacted by the Senate and House of Representatives of the Philippines in
Congress assembled:*

1 SECTION 1. June 21 of every year is hereby declared a special
2 nonworking holiday in Tagaytay City, Province of Cavite in commemoration
3 of its foundation day to be known as "Charter Day of Tagaytay City" or "Araw
4 ng Lungsod ng Tagaytay".

5 SEC. 2. This Act shall take effect fifteen (15) days after its publication
6 in the *Official Gazette* or in a newspaper of general circulation.
