#### MR, PRESIDENT:

The Committee on Local Government to which was referred House Bill No. 3969, introduced by Representatives Advincula and Primicias-Agabas, entitled:

#### "AN ACT

DECLARING JUNE 30 OF EVERY YEAR A SPECIAL NONWORKING HOLIDAY IN THE CITY OF IMUS, PROVINCE OF CAVITE IN COMMEMORATION OF ITS FOUNDING ANNIVERSARY"

has considered the same and has the honor to report it back to the Senate with the recommendation that it be approved with the following amendments:

1. On page 1, line 2, delete the word "nonworking" and in lieu thereof insert the word "WORKING";

- On the same page and line, after the word "holiday" insert the phrase "AND NO CLASS DAY IN SCHOOLS";
- 3. On the same page, line 3, after the word "anniversary" insert a new section to read as follows:

"SECTION 2. FOR WORK PERFORMED ON A SPECIAL WORKING HOLIDAY, AN EMPLOYEE IS ENTITLED TO HIS/HER REGULAR WAGE."

and renumber the succeeding sections accordingly;

4. The title of the bill should now read as follows:

"AN ACT DECLARING JUNE 30 OF EVERY YEAR A SPECIAL WORKING HOLIDAY AND NO CLASS DAY IN SCHOOLS IN THE CITY OF IMUS, PROVINCE OF CAVITE IN COMMEMORATION OF ITS FOUNDING ANNIVERSARY"
