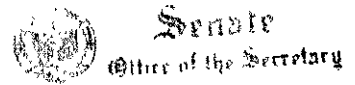

MR. PRESIDENT:

The Committee on Local Government to which was referred House Bill No. 4646, introduced by Representatives Gorriceta, Tupas, Garin O. Trefias, Biron, Defensor and Primicias-Agabas, entitled:

**“AN ACT
DECLARING DECEMBER 29 OF EVERY YEAR A SPECIAL NONWORKING
HOLIDAY IN THE MUNICIPALITY OF LEON, PROVINCE OF ILOILO IN
HONOR OF CAPTAIN JOSE CALUGAS SR. TO BE KNOWN SA “JOSE
CALUGAS DAY””**

has considered the same and has the honor to report it back to the Senate with the recommendation that it be approved with the following amendments:

1. On page 1, line 2, delete the word “nonworking” and in lieu thereof insert the word **“WORKING”**;

2. On the same page and line, after the word "holiday" insert the phrase **"AND NO CLASS DAY IN SCHOOLS";**

3. On the same page, line 3, after the word "Day", insert a new section to read as follows:

"SECTION 2. FOR WORK PERFORMED ON A SPECIAL WORKING HOLIDAY, AN EMPLOYEE IS ENTITLED TO HIS/HER REGULAR WAGE."

and renumber the succeeding sections accordingly;

4. The title of the bill should now read as follows:

"AN ACT DECLARING DECEMBER 29 OF EVERY YEAR A SPECIAL WORKING HOLIDAY AND NO CLASS DAY IN SCHOOLS IN THE MUNICIPALITY OF LEON, PROVINCE OF ILOILO IN HONOR OF CAPTAIN JOSE CALUGAS SR. TO BE KNOWN AS "JOSE CALUGAS DAY"







AN ACT DECLARING DECEMBER 29 OF EVERY YEAR A SPECIAL
NONWORKING HOLIDAY IN THE MUNICIPALITY OF LEON,
PROVINCE OF ILOILO IN HONOR OF CAPTAIN JOSE CALUGAS
SR. TO BE KNOWN AS "JOSE CALUGAS DAY"

*Be it enacted by the Senate and House of Representatives of the Philippines in
Congress assembled:*

1 SECTION 1. December 29 of every year is declared a special
2 nonworking holiday in the Municipality of Leon, Province of Iloilo in honor of
3 Captain Jose Calugas Sr. to be known as "Jose Calugas Day".

4 SEC. 2. This Act shall take effect fifteen (15) days after its publication
5 in the *Official Gazette* or in a newspaper of general circulation.
