Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:

- 1 SECTION 1. August 11 of every year is declared a special nonworking
- 2 holiday in the City of Ilagan, Province of Isabela in commemoration of its
- 3 Charter Day Anniversary to be known as "Ilagan City Charter Day". When
- 4 the holiday falls on a Saturday or a Sunday, the special nonworking day shall
- 5 be observed on the Monday that follows.
- 6 SEC. 2. This Act shall take effect fifteen (15) days after its publication
- 7 in the Official Gazette or in a newspaper of general circulation.
