
has considered the same and has the honor to report it back to the Senate with the recommendation that it be approved with the following amendments:





CHARTER DAY ANNIVERSARY TO BE KNOWN AS
"ILAGAN CITY CHARTER DAY"

*Be it enacted by the Senate and House of Representatives of the Philippines in
Congress assembled:*

1 SECTION 1. August 11 of every year is declared a special nonworking
2 holiday in the City of Ilagan, Province of Isabela in commemoration of its
3 Charter Day Anniversary to be known as "Ilagan City Charter Day". When
4 the holiday falls on a Saturday or a Sunday, the special nonworking day shall
5 be observed on the Monday that follows.

6 SEC. 2. This Act shall take effect fifteen (15) days after its publication
7 in the *Official Gazette* or in a newspaper of general circulation.
