The Senate Committees on Public Services and on Finance to which were referred H. B. No. 2028, introduced by Representatives Acop, Sarmiento and Ungab, *entitled*:


**“AN ACT

have considered the same and have the honor to report it back to the Senate with the recommendation that the attached H. B. No. 2028 be approved with amendments, *to wit*:


1. On page 1 line 1, after the conjunctive “a” and before the word “Land”, insert the words “REGULAR DISTRICT OFFICE OF THE”;
2. On page 1, line 2, after the letters “(LTO)”, delete the words “district office”;
3. On page 1 beginning line 3 up to line 5, delete the entire Sec. 2 and re-number the succeeding sections accordingly;
4. Still on page 1, line 11, after the word “Gazette” delete the period and add the phrase “OR IN A NEWSPAPER OF GENERAL CIRCULATION”, and
5. Lastly, on the title, the new title shall read as follows,

**“AN ACT ESTABLISHING A REGULAR DISTRICT OFFICE
OF THE LAND TRANSPORTATION OFFICE IN THE CITY
OF ANTIPOLO, PROVINCE OF RIZAL AND
APPROPRIATING FUNDS THEREFOR.”**





BY REPRESENTATIVES ACOP, SARMIENTO (C.) AND UNGAB

AN ACT ESTABLISHING A LAND TRANSPORTATION OFFICE (LTO) DISTRICT OFFICE IN THE CITY OF ANTIPOLO, PROVINCE OF RIZAL AND APPROPRIATING FUNDS THEREFOR

Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:

1 SECTION 1. There shall be established a Land Transportation Office
2 (LTO) District Office in the City of Antipolo, Province of Rizal.

3 SEC. 2. The Department of Transportation and Communications shall
4 issue the necessary rules and regulations for the effective implementation of
5 this Act.

6 SEC. 3. The Secretary of Transportation and Communications shall
7 immediately include in the Department's programs the operationalization of
8 the LTO District Office in the City of Antipolo, Province of Rizal, the funding
9 of which shall be included in the annual General Appropriations Act.

10 SEC. 4. This Act shall take effect fifteen (15) days after its publication
11 in the *Official Gazette*.
