The Senate Committees on Public Services and on Finance to which were referred H. B. No. 540, introduced by Representatives Mercado-Revilla, Sarmiento and Ungab, entitled:


**"AN ACT  
ESTABLISHING A DISTRICT OFFICE OF THE LAND  
TRANSPORTATION OFFICE (LTO) IN THE CITY OF  
BACOR, PROVINCE OF CAVITE AND APPROPRIATING  
FUNDS THEREFOR."**

have considered the same and have the honor to report it back to the Senate with the recommendation that the attached H. B. No. 540 be approved with amendments, *to wit*:

4. Still on the same page 1, line 11, before the conjunctive in, insert the words "THE OFFICIAL GAZETTE OR IN", and
5. Lastly, on the title. The new title shall read as follows,

**"AN ACT ESTABLISHING A REGULAR DISTRICT OFFICE  
OF THE LAND TRANSPORTATION OFFICE (LTO) IN THE  
CITY OF IMUS, PROVINCE OF CAVITE AND  
APPROPRIATING FUNDS THEREFOR."**





**AN ACT ESTABLISHING A DISTRICT OFFICE OF THE LAND  
TRANSPORTATION OFFICE (LTO) IN THE CITY OF BACOR,  
PROVINCE OF CAVITE AND APPROPRIATING FUNDS  
THEREFOR**

*Be It enacted by the Senate and House of Representatives of the Philippines in  
Congress assembled:*

1           SECTION 1. There shall be established, under the supervision of the  
2 Land Transportation Office (LTO) Main Office in Quezon City, a District  
3 Office of the LTO in the City of Bacoor, Province of Cavite.

4           SEC. 2. The Secretary of Transportation and Communications shall  
5 immediately include in the Department's programs the operationalization of  
6 the LTO District Office in the City of Bacoor, Province of Cavite, the funding  
7 of which shall be included in the annual General Appropriations Act.

8           SEC. 3. The Chairperson of the LTO shall issue such rules and  
9 regulations as may be necessary to carry out the purpose of this Act.

10          SEC. 4. This Act shall take effect fifteen (15) days after its publication  
11 in a newspaper of general circulation.
