Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled: , i

SECTION 1. There shall be established, under the supervision of the
 Land Transportation Office (LTO) Main Office in Quezon City, a District
 Office of the LTO in the City of Bacoor, Province of Cavite.

SEC. 2. The Secretary of Transportation and Communications shall
immediately include in the Department's programs the operationalization of
the LTO District Office in the City of Bacoor, Province of Cavite, the funding
of which shall be included in the annual General Appropriations Act.

- 8 SEC. 3. The Chairperson of the LTO shall issue such rules and 9 regulations as may be necessary to carry out the purpose of this Act.
- SEC. 4. This Act shall take effect fifteen (15) days after its publication
  in a newspaper of general circulation.
