AN ACT ESTABLISHING A LAND TRANSPORTATION OFFICE IN THE MUNICIPALITY OF MALITA, PROVINCE OF DAVAO OCCIDENTAL AND APPROPRIATING FUNDS THEREFOR

Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:

i	SECTION 1. There shall be established a regular district of the Land
2	Transportation Office (LTO) in the Municipality of Malita, Province of Davao
3	Occidental to be known as the Malita Land Transportation District Office
4	which shall exercise jurisdiction over all municipalities of the province.
5	SEC. 2. The head of the LTO District Office shall be appointed by the
6	Secretary of Transportation and Communications and shall be assisted by a
7	staff to be appointed by the Secretary of Transportation and Communications
8	in accordance with existing laws.
9	SEC. 3. The Secretary of the Department of Transportation and
10	Communications shall immediately include in the Department's programs the
11	operationalization of the LTO District Office in the Municipality of Malita
12	Province of Davao Occidental, the funding of which shall be included in the
13	annual General Appropriations Act.

- 1 SEC. 4. This Act shall take effect fifteen (15) days following its
- publication in the Official Gazette or in a newspaper of general circulation.
