AN ACT ESTABLISHING A DISTRICT OFFICE OF THE LAND TRANSPORTATION OFFICE (LTO) IN THE MUNICIPALITY OF CARMONA, PROVINCE OF CAVITE AND APPROPRIATING FUNDS THEREFOR

Be it enacted by the Senate and House of Representatives of the Philippines In Congress assembled:

- SECTION 1. A Land Transportation Office (LTO) District Office in the Municipality of Carmona, Province of Cavite is hereby established.
- SEC. 2. The Department of Transportation and Communications shall issue necessary rules and regulations to implement the establishment of the said office.
- SEC. 3. The amount needed for the operationalization of the LTO
 District Office in the Municipality of Carmona, Province of Cavite shall be
 included in the annual General Appropriations Act.
- SEC. 4. This Act shall take effect fifteen (15) days after its publication in the Official Gazette or in a newspaper of general circulation.
