MR. PRESIDENT:

The Senate Committees on Public Services and on Finance to which were referred H. B. No. 2592, introduced by Representatives Tambunting, Sarmiento and Ungab, entitled:


**"AN ACT  
CONVERTING THE LAND TRANSPORTATION OFFICE SATELLITE  
OFFICE AS DISTRICT OFFICE IN DISTRICT 2, PARAÑAQUE CITY AND  
PROVIDING FUNDS THEREFOR."**


have considered the same and have the honor to report it back to the Senate with the recommendation that the attached H. B. No. 2592 be approved with amendments, *to wit*:

1. On page 1, line 6, after the word "City," delete the phrase "the funding of which shall be included in the annual General Appropriations Act." and replace it with the phrase "THE INITIAL FUNDING OF WHICH SHALL BE CHARGED AGAINST THE CURRENT YEAR'S APPROPRIATIONS OF THE SATELLITE OFFICE LOCATED IN DISTRICT 2 PARAÑAQUE CITY. THEREFTER, SUCH SUMS AS MAYBE NECESSARY FOR THE CONTINUED OPERATION OF THE LTO DISTRICT OFFICE SHALL BE INCLUDED IN THE GENERAL APPROPRIATIONS ACT"
2. On the same page 1 line 8, delete the entire Section 3 and re-number the succeeding sections accordingly;
3. On the same page 1, line 12, between the conjunctive words "in" and "at" insert the words "THE OFFICIAL GAZETTE OR IN A";
4. Still on page 1 and line 12, after the conjunctive "at" and before the word "newspapers", delete the words "at least two (2)";
5. On the same page and line 12, delete the letter "s" from the word "newspapers", and
6. Lastly, on the title. The new title shall read as follows,

**"AN ACT CONVERTING THE SATELLITE OFFICE OF THE  
LAND TRANSPORTATION OFFICE (LTO) IN DISTRICT 2,  
PARAÑAQUE CITY INTO A REGULAR LTO DISTRICT  
OFFICE AND APPROPRIATING FUNDS THEREFOR."**

AN ACT CONVERTING THE LAND TRANSPORTATION OFFICE  
SATELLITE OFFICE AS DISTRICT OFFICE IN DISTRICT 2,  
PARAÑAQUE CITY AND PROVIDING FUNDS THEREFOR

*Be it enacted by the Senate and House of Representatives of the Philippines in  
Congress assembled:*

1           SECTION 1. The existing Land Transportation Office (LTO) Satellite  
2 Office in District 2, Parañaque City is hereby converted into a regular LTO  
3 District Office.

4           SEC. 2. The Secretary of Transportation and Communications shall  
5 include in the Department's program the operationalization of a District Office  
6 of the Land Transportation Office in District 2, Parañaque City, the funding of  
7 which shall be included in the annual General Appropriations Act.

8           SEC. 3. The Assistant Secretary of the Land Transportation Office shall  
9 issue rules and regulations as may be necessary to carry out the purposes of  
10 this Act.

11           SEC. 4. This Act shall take effect fifteen (15) days after its complete  
12 publication in at least two (2) newspapers of general circulation.
